APPROVE THE ASSIGNMENT OF 100 PERCENT INTEREST IN STATE OIL AND GAS LEASES PRC 7282 AND PRC 7658, YOLO AND SUTTER COUNTIES

#### **BACKGROUND:**

On February 6, 1989, the State Lands Commission issued a negotiated sub-surface oil and gas lease (PRC 7282) to Black Mountain Oil Company (Black Mountain). The lease consists of approximately 110 acres of State land in the bed of the Sacramento River, Sutter and Yolo Counties. On September 23, 1992, the Commission approved a request by Black Mountain to increase the acreage to 320 acres, of which 54.06 acres will be incorporated into a pooling agreement. On September 23, 1992, the Commission approved a second negotiated oil and gas lease (PRC 7658) of approximately 539 acres in the same general vicinity to Black Mountain.

# CALENDAR ITEM NO. C48 (CONT'D)

Black Mountain has acquired oil and gas leases and a farm-out agreement on all the private land adjacent to the State parcel. Drill sites on the State parcel are not available or obtainable because the surface of the State parcels are the bed of the Sacramento River and are covered completely with water. However, the State parcels are being developed by slant drilling from surface drill sites on adjacent land.

On August 4, 1992, staff was contacted by Black Mountain requesting Commission approval to assign 100 percent of its interest in these leases to Montis Niger, Incorporated.

Lease Paragraph No. 29 provides that the Lessee, with Commission approval, may assign any portion of the lease to a corporation that possesses the qualifications within P.R.C. 6801. The leases also specify that the assignment will take effect on the first day of the month following Commission approval.

Staff has reviewed the documents and lease files and have found that: (1) the Assignee is qualified under P.R.C. Section 6801 to hold the lease, (2) the lessee has complied with all lease provisions and no default exists, and (3) all filing fees, processing costs and required documentation are on file in the Commission's offices in Long Beach.


