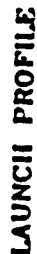

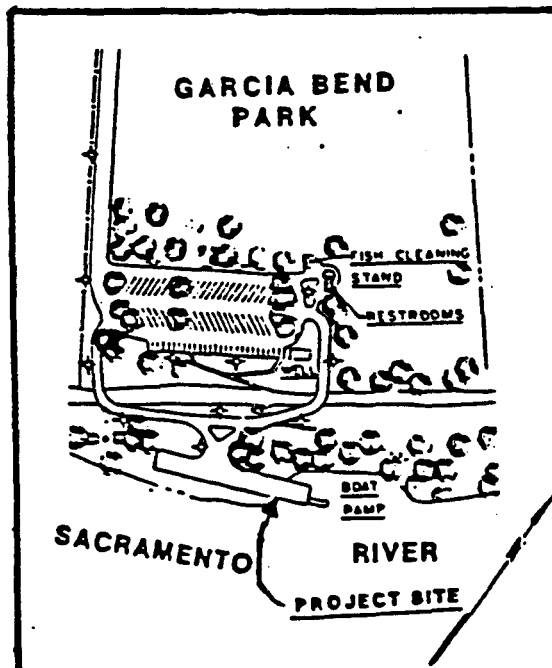
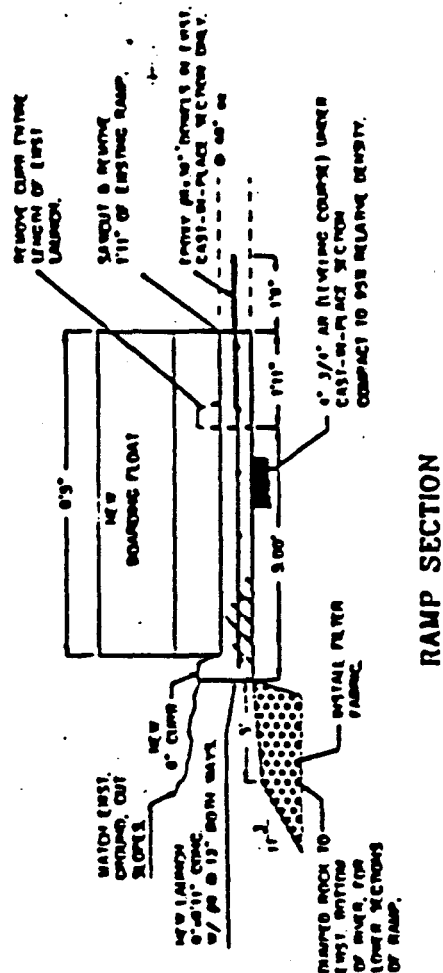

CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO
P.R.C. 6370, ET. SEQ.

AUTHORIZATION:

AUTHORIZE ISSUANCE TO THE CITY OF SACRAMENTO OF A FIFTEEN (15) YEAR GENERAL LEASE - PUBLIC AGENCY USE BEGINNING JUNE 1, 1990; BOAT LAUNCH RAMP AND BOARDING FLOAT - PUBLIC USE AND BENEFIT, WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; DREDGING - IF THE DREDGED SPOILS ARE SOLD OR USED FOR A COMMERCIAL PURPOSE, THEN LESSEE AGREES TO PAY A ROYALTY OF 10% OF THE GROSS SALES PRICE, BUT NOT LESS THAN \$0.25 PER CUBIC YARD; FOR CONTINUED USE AND MAINTENANCE OF AN EXISTING BOAT LAUNCH RAMP AND BOARDING FLOAT, PROPOSED WIDENING OF BOAT LAUNCH RAMP, REPLACEMENT AND UPGRADING THE BOARDING FLOAT, PLACEMENT OF RIPRAP UNDER THE NEW PORTION OF THE BOAT LAUNCH RAMP AND DREDGING TO A MAXIMUM OF 20 CUBIC YARDS DURING INITIAL CONSTRUCTION AND TO A MAXIMUM OF 100 CUBIC YARDS ANNUALLY THEREAFTER FOR THE REMAINING PERIOD OF THE LEASE TERM; ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.



This Land description is solely for purposes of generally defining the lease premises, and is not intended to be, nor shall it be construed as, a waiver or limitation of any State interest in the subject or any other property.
