AUTHORIZE FILING A DISCLAIMER
OF SOVEREIGN TITLE INTERESTS IN
HUNT V. CROCKER, ET AL.,
ORANGE COUNTY SUPERIOR COURT NO. 722433

The State is named as a cross-defendant in this quiet title action due to issues involving the location and title of Santiago Creek in §29, T 5 S, R 7 W, SB&B, in the vicinity of the Cleveland National Forest in Orange County. The title to two adjacent properties is purportedly divided by the center line of Santiago Creek. This creek was allegedly the subject of a substantial flood which caused a change in the location of the creek and its center line.

The staff of the Commission has examined the Commission's records pertaining to the area and has ascertained that there is no sovereign title interest which is held by the State of California and under the jurisdiction of the Commission with respect to the lands involved in the quiet title action.

Because the property does involve a creek, it is necessary to caveat the Commission's disclaimer so as not to waive any possible public right of recreation that may exist if this waterway is subject to recreational navigation (see <u>People ex rel. Baker v. Mack</u> (1971) 19 Cal App 3rd 560).

Therefore, since this action involves land over which the Commission asserts no sovereign title interest, staff recommends that the Commission authorize the Attorney General to file on its behalf a limited disclaimer of any sovereign title interests in the land, subject to any public rights in recreationally navigable waters which may exist on the property.

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.


