APPROVE SUSPENSION OF CONTINUOUS PRODUCTION OPERATIONS, STATE OIL AND GAS LEASE PRC 186, BELMONT OFFSHORE FIELD, ORANGE COUNTY

APPLICANT:

Exxon Company, U.S.A. Mr. Steven B. Dixon P. O. Box 3116 Midland, Texas 79702-3116

AREA, TYPE LAND AND LOCATION:

State oil and gas lease PRC 186 contains approximately 1,225 acres of tide and submerged lands located within the Belmont Offshore Field, Orange County.

LAND USE:

Oil and gas exploration and development.

BACKGROUND:

State oil and gas lease PRC 186 was issued to Marine Exploration Company on September 24, 1945. Through a series of assignments and name changes, Exxon Company, U.S.A. (Exxon) and Texaco Exploration and Production, Inc., each own an undivided 50 percent interest in the lease.

Paragraph 11 of the lease provides that the lessee exercise reasonable diligence in the operation of its wells and shall not unreasonably suspend continuous operations except with the consent of the State. Exxon, operator of the lease, has requested approval of the suspension of operations pending its preparation of an application for the abandonment of wells and facilities and discussions for transfer of the leasehold interests with adjoining lessees. Exxon will also pursue alternative uses of Belmont Island with other private and public parties. It is estimated that the required analysis of the various lease and development options will take approximately two years.
