OTHER PERTINENT INFORMATION:

This amendment authorizes the construction of a previously authorized floating dock which was never constructed due to the fact that portions of the proposed dock extended onto an easement, the ownership and terms which were the subject of a dispute between the applicant and his neighbor. A court judgment determined that the terms of the right of way easement did not give the applicant the right to construct the proposed dock within the right of way.

The proposed amendment is intended to solve this easement problem by moving the location of the proposed dock well away from the right-of-way to a portion of the shoreline where the applicant owns fee title. The proposed new dock will be smaller than the dock originally approved by the Commission resulting in less structural fill of the river.




