## OTHER PERTINENT INFORMATION:

 The California Department of Parks and Recreation (DPR) has applied for a salvage permit to map, identify, and retrieve surface artifacts from the shipwreck "Frolic."

The project will enable DPR to identify the extent and integrity of the remains of the "Frolic," and assist DPR in evaluating the site for possible inclusion in the State park system as an underwater park.

The "Frolic" is a Baltimore Clipper built in 1844 which was used to transport opium from Bombay to Canton. The ship sank off the Mendocino coast in 1850 while transporting Chinese goods.

DPR has contracted with San Jose State University Foundation to perform the underwater mapping project. Curation of artifacts is being done at the Mendocino County Museum in Willits, with eventual exhibition at a proposed State park facility at Point Cabrillo.

 Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15025), the staff has prepared a Proposed Negative Declaration identified as EIR ND 510, State Clearinghouse No. 89030070. Such Proposed Negative Declaration was prepared and circulated for public review pursuant to the provisions of CEQA.

Based upon the Initial Study, the Proposed Negative Declaration, and the comments received in response thereto, there is no substantial evidence that the project will have a significant effect on the environment. (14 Cal. Code Regs. 15074(b).)


