DREDGING LEASE

LESSEE:

Benicia Port Terminal P. O. Box 315 Benicia, California 94510

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Carquinez Strait at the Benicia Port Terminal Dock, city of Benicia, Solano County.

AUTHORIZED USE:

Maintenance dredge a maximum of 90,000 cubic yards of material annually to maintain a navigable depth. Dredged materials will be disposed of at the United States Army Corps of Engineers approved Carquinez Strait Disposal Site (SF-9).

LEASE TERM:

Five years, beginning January 1, 1998.

CONSIDERATION:

No royalty will be charged for aquatic disposal; \$0.25 per cubic yard will be charged for any material used for private benefit or commercial sale purposes.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land; Title 14, California Code of Regulations, section 15304(g).
