APPLICANTS:

Dennis H. Grimsman and Diane S. Grimsman 120 Selby Lane Atherton, California 94025

AREA, LAND TYPE, AND LOCATION:

0.10 acre, more or less, of sovereign lands in Lake Tahoe, near Cedar Flat, Placer County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier and one mooring buoy, as shown on the Attached Exhibit A.

LEASE TERM:

Ten years, beginning June 30, 1997.

CONSIDERATION:

\$778 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Combined single limit liability coverage of no less than \$500,000.

Other:

This lease is conditioned on lessee obtaining authorization from the Tahoe Regional Planning Agency for the mooring buoy within two years from the effective date of the authorization of the buoy by the Commission.

- 1. Applicants are the owners of the upland parcel which adjoins the lease premises but is not littoral.
- 2. Staff recommends the collection of \$1,998.36 in rent to cover the period of 6/30/90 through 6/29/97; \$778 per year from 6/30/97 henceforth.
- 3. **PIER:** Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a) (2).

The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905 (c) (3).
