# RECREATIONAL PIER LEASE

### **APPLICANTS:**

Wallace B. Vandewark and Barbara D. Vandewark, Trustees and Successor Trustee of the Vandewark Revocable Trust U/D 12/11/95 P. O. Box 899 Homewood, California 96141

### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, Meeks Bay, El Dorado County.

#### **AUTHORIZED USE:**

Use and maintenance of a pier and two mooring buoys, as shown on the attached Exhibit A.

### LEASE TERM:

Ten years, beginning November 1, 1997.

### **CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

# **SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance in the amount of no less than \$300,000.

Other:

This lease is conditioned on lessee obtaining authorization from the Tahoe Regional Planning Agency for the mooring buoys within two years from the effective date of the authorization of the buoys by the Commission.
