**GRAZING LEASE**

**APPLICANTS:**

John Matley and Son  
428-795 Constantia Road  
Doyle, California 96109

**AREA, LAND TYPE, AND LOCATION:**

1,080 acres, more or less, of State School Lands located near Doyle, Plumas  
County.

**AUTHORIZED USE:**

Continued use of cattle grazing, for the area shown on Exhibit A attached.

**LEASE TERM:**

Ten years, beginning March 20, 1998.

**CONSIDERATION:**

\$500 per year; with the State reserving the right to fix a different rent periodically  
during the lease term, as provided in the lease.

**SPECIFIC LEASE PROVISIONS:**

Liability insurance in the amount of no less than \$500,000.

**OTHER PERTINENT INFORMATION:**

1. The rent for this lease is the minimum annual rent the Commission  
charges for grazing leases.
2. Pursuant to the Commission's delegation of authority and the State CEQA  
Guidelines (Title 14, California Code of Regulations, section 15061), the  
staff has determined that this activity is exempt from the requirements of  
the CEQA as a categorically exempt project. The project is exempt under  
Class 4, Minor Alteration to Land; Title 2, California Code of Regulations,  
section 2905 (d)(1).

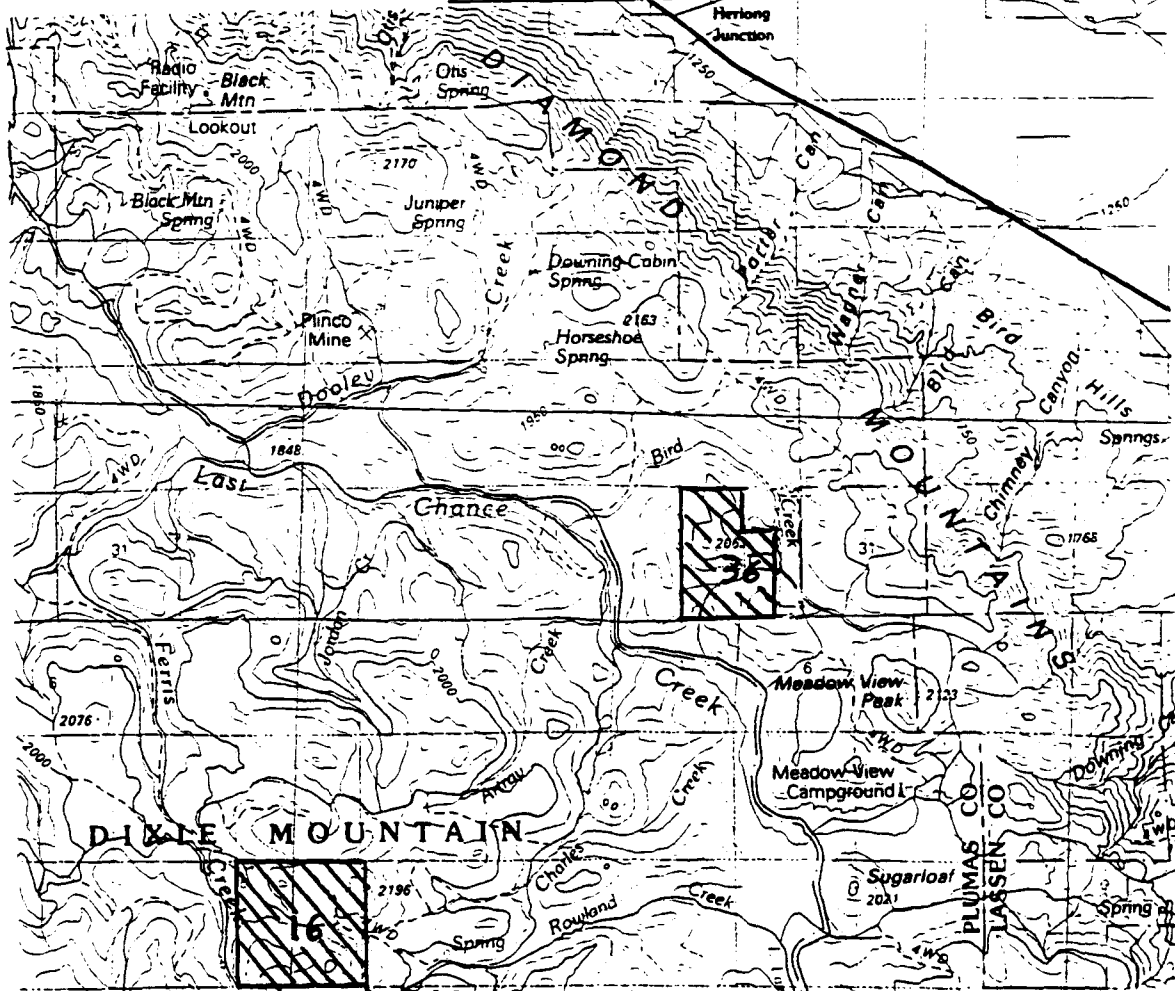

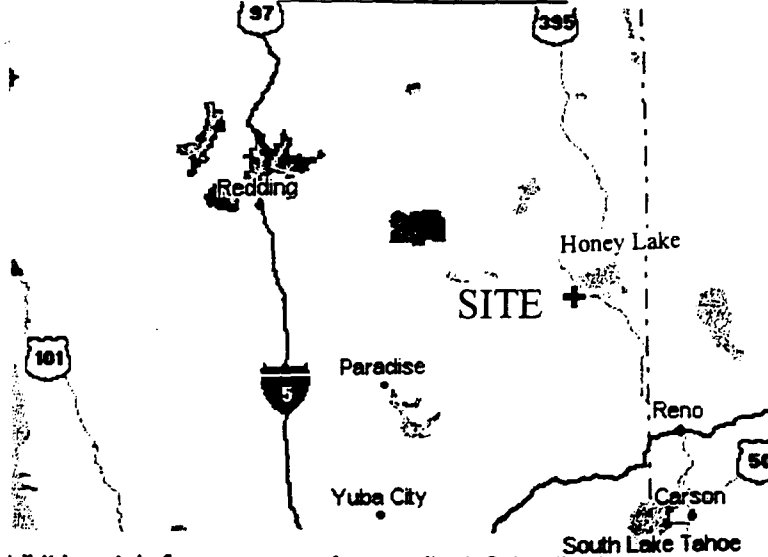
