**RECREATIONAL PIER LEASE**

**APPLICANTS:**

Stanley Hiller, Jr. and Carolyn B. Hiller, Trustee U/T/A  
Dated September 23, 1983  
601 Skyway Road  
San Carlos, California 94070

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in Lake Tahoe, near Tahoma, Placer County.

**AUTHORIZED USE:**

Continued use and maintenance of a multi-use pier, three boat lifts and four mooring buoys, as shown on the attached Exhibit A.

**LEASE TERM:**

Ten years, beginning June 1, 1999.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

**Insurance:**

Liability insurance in the amount of no less than \$300,000.

**Other:**

This lease is conditioned on Lessee's obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years from the effective date of the authorization of the buoys by the Commission.

The project is exempt under Class 3, New Construction of Small Structures; Title 14, California Code of Regulations, section 15303 (e).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300.

**TWO ADDITIONAL MOORING BOUYS:** Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905 (c)(3).

2. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

3. In 1996, the Tahoe Regional Planning Agency authorized the additional boat lift for a total of three boat lifts attached to the multiple use pier.
4. The lease is conditioned on the lessee obtaining written authorization for the two additional buoys from the Tahoe Regional Planning Agency within two years from the effective date of the authorization of the buoys by the Commission.

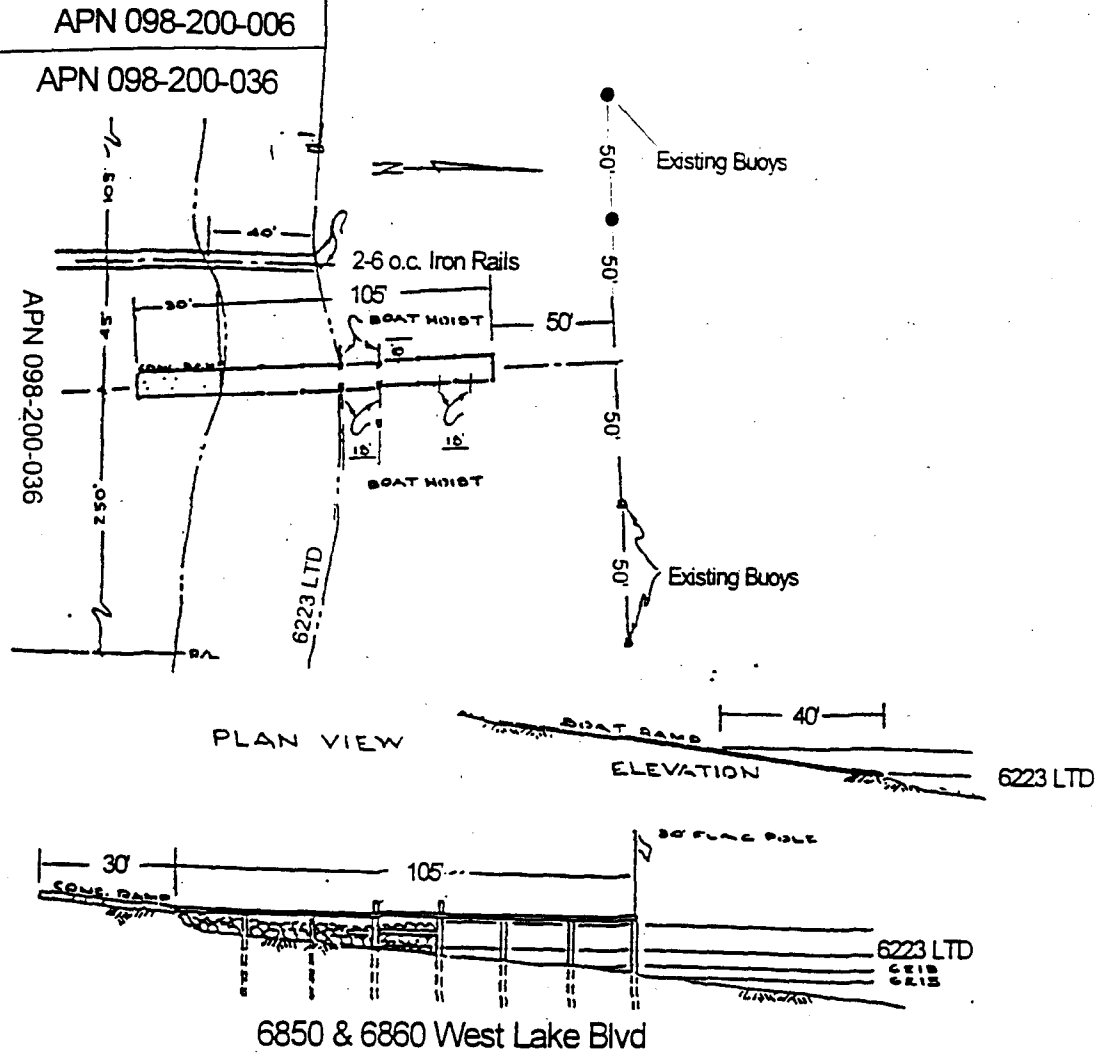

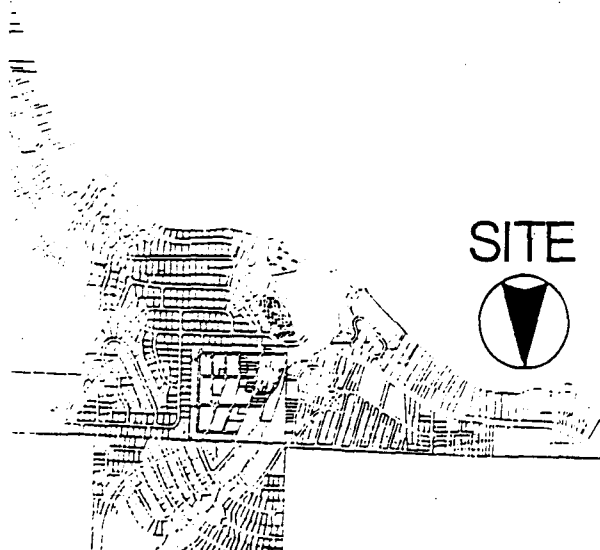
# SITE MAP

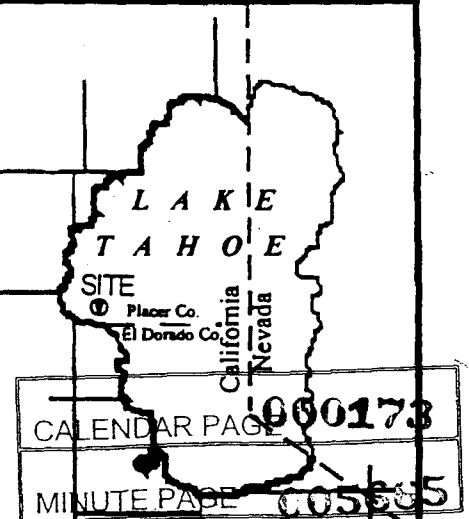
# LOCATION MAP
