DREDGING AND DISPOSAL LEASE

APPLICANT:

Crescent City Harbor District
101 Citizens Dock Road
Crescent City, CA 95531

AREA, LAND TYPE, AND LOCATION:

Granted sovereign lands, with minerals reserved to the State, in the Crescent City Harbor, near Crescent City, Del Norte County.

AUTHORIZED USE:

Maintenance dredge a maximum of 10,000 cubic yards of material in the Crescent City Harbor at Fashion Blacksmith, A-Dock, E-Dock, H-Dock, and the launch-ramp. Dredged material will be disposed of at the Crescent City Harbor District's existing upland disposal site located immediately north of the inner basin.

LEASE TERM:

Three months, beginning July 1, 1999.

CONSIDERATION:

No royalty will be charged as the project will result in a public benefit. A royalty of a minimum of \$0.25 per cubic yard shall be paid for any material sold or used for any private benefit or commercial sale purposes.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land; Title 14, California Code of Regulations, section 15304(g).

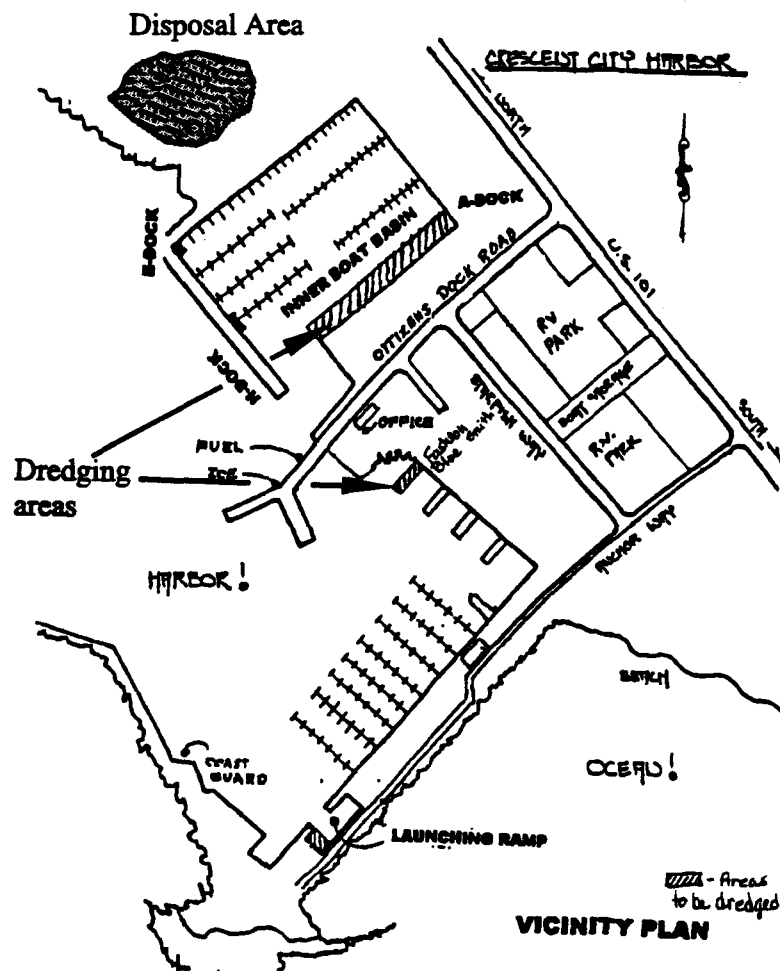

AUTHORIZATION:

AUTHORIZE THE ISSUANCE OF A DREDGING AND DISPOSAL LEASE TO CRESCENT CITY HARBOR DISTRICT BEGINNING JULY 1, 1999, FOR A TERM OF THREE MONTHS, ENDING ON SEPTEMBER 30, 1999, FOR MAINTENANCE DREDGING OF A MAXIMUM OF 10,000 CUBIC YARDS OF MATERIAL IN THE CRESCENT CITY HARBOR DISTRICT AT FASHION BLACKSMITH, A-DOCK, E-DOCK, H-DOCK, AND THE LAUNCH-RAMP; DREDGED MATERIAL WILL BE DISPOSED OF AT THE CRESCENT CITY HARBOR DISTRICT'S UPLAND DISPOSAL SITE LOCATED IMMEDIATELY NORTH OF THE INNER BASIN ON THE LANDS SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; NO ROYALTY SHALL BE CHARGED BECAUSE THE PROJECT IS FOR PUBLIC BENEFIT. \$0.25 PER CUBIC YARD SHALL BE CHARGED FOR ANY MATERIAL USED FOR PRIVATE BENEFIT OR COMMERCIAL SALE PURPOSES. SUCH PERMITTED ACTIVITY IS CONTINGENT UPON APPLICANT'S COMPLIANCE WITH APPLICABLE PERMITS, RECOMMENDATIONS, OR LIMITATIONS ISSUED BY FEDERAL, STATE AND LOCAL GOVERNMENTS.

LOCATION MAP

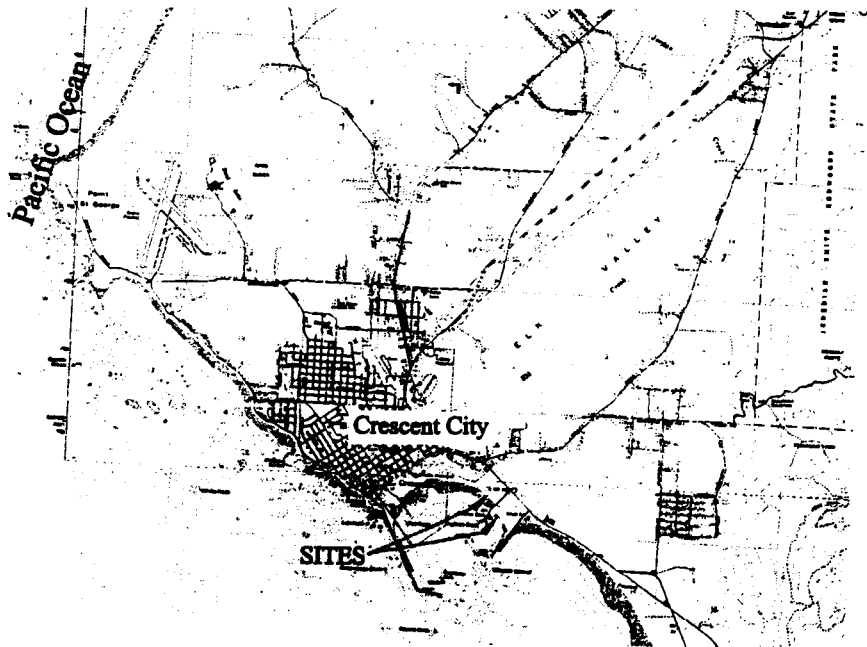
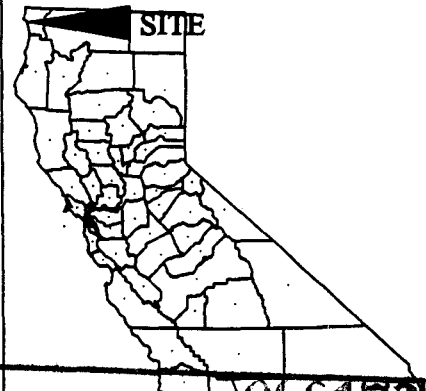
