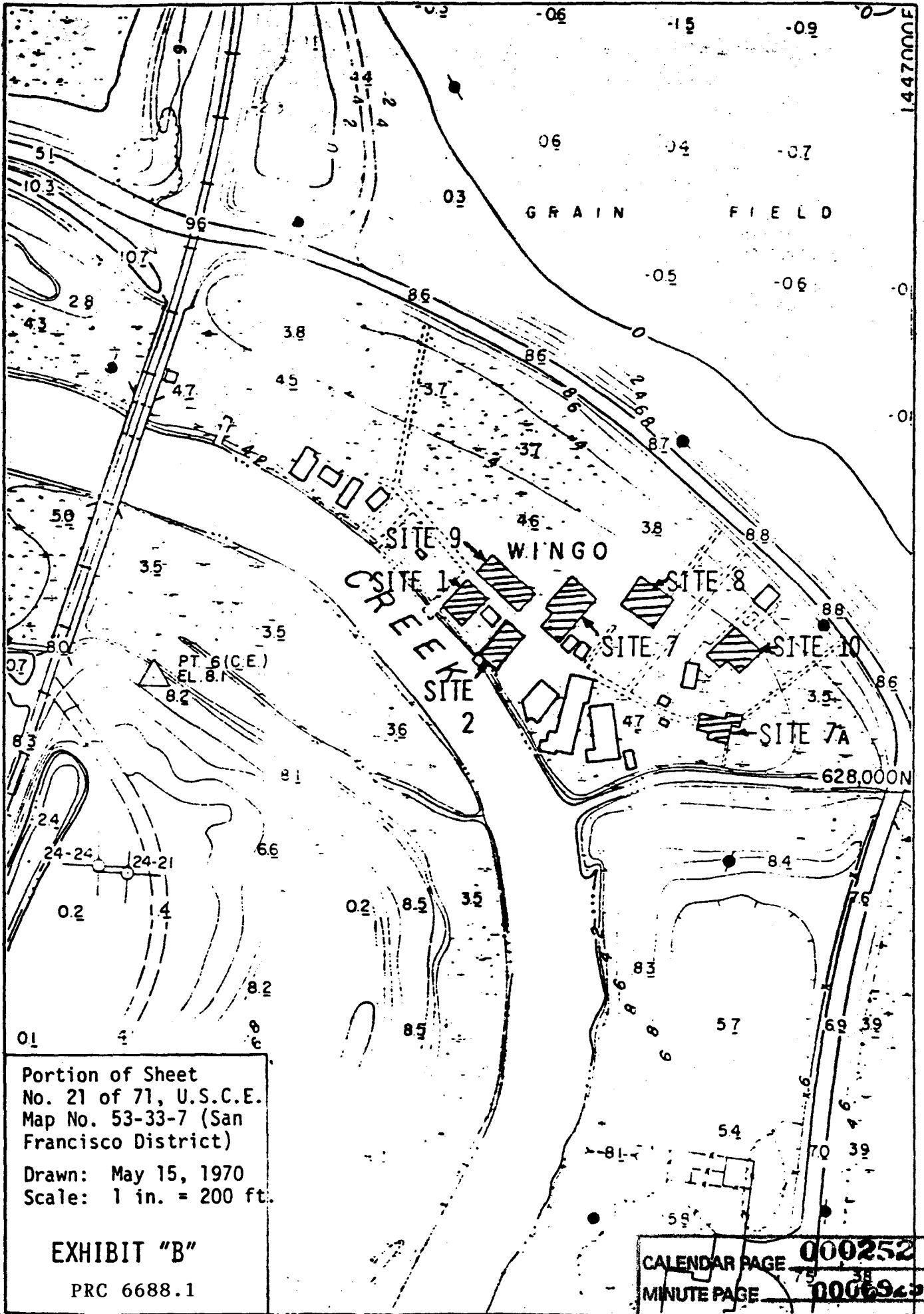
SITES-1 and 9
