AMENDMENT OF LEASE

LESSEE:

Pacific Gas and Electric Company Attn: Mr. Randy Burton 1030 Detroit Avenue

Concord, CA 94518-2487

AREA, LAND TYPE, AND LOCATION:

3 acres, more or less, of sovereign lands in the beds of Pacheco Creek and Hastings Slough in the town of Crockett, Contra Costa County.

AUTHORIZED USE:

Continued use and maintenance of a 16-inch hot oil pipeline.

LEASE TERM:

15 years beginning August 1, 1975, with two successive ten-year renewal options.

CONSIDERATION:

\$5,040 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

PROPOSED AMENDMENT:

The proposed amendment will authorize the relocation of a portion of the pipeline in the town of Crockett.

OTHER PERTINENT INFORMATION:

- 1. This project is occurring because of the California Department of Transportation's construction of a new west span for the Carquinez Strait Bridge, as part of the seismic retrofit project.
- 2. The California Fire Marshall will inspect the relocated pipeline.

- This entire pipeline has not been in service since May 1998.
- 4. The California Department of Transportation, the Lead Agency pursuant to the California Environmental Quality Act (CEQA), has determined that the Carquinez Bridge Project is statutorily exempt from the requirements of the CEQA under California Streets and Highways Code Section 180.2 and CEQA section 21080 (b)(4). An EIS was adopted for the bridge project by the Federal Highway Administration and United States Coast Guard. Relocation of the hot oil pipeline is a necessary component of the Carquinez Bridge Project.

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a statutorily exempt project. The project is exempt because it involves specific actions necessary to prevent or mitigate an emergency.

Authority: Public Resources Code section 21080 (b)(4) and Title 14, California Code Regulations, section 15269 (c).

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

LAND DESCRIPTION

A portion of State-owned tide and submerged land in the Carquinez Straits, Contra Costa County, California described as follows:

An underground utility easement for an oil pipe and incidents thereto, upon, across and under a 9.200 meter wide strip of land, the centerline of which is described as follows:

Beginning for reference at the corner common to Sections 31 and 32, T3N, R3W, and Sections 5 and 6, T2N, R3W, MDM, thence N.73°44′42″W., 99.588 meters to the TRUE POINT OF BEGINNING of said strip; thence S.53°33′23″E., 20.470 meters; thence S.89°26′12″E., 65.100 meters; thence N.22°32′03″E., 61.650 meters to the end of said centerline.

Containing 1,354 square meters, more or less.
