RECREATIONAL PIER LEASE

APPLICANTS:

Robert W. Linville and Lou Ann M. Linville
589 W. Brannan Island Road
Isleton, California 95641

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the San Joaquin River at Andrus Island, near the city of
Rio Vista, Sacramento County.

AUTHORIZED USE:

Continued use and maintenance of an existing 21 foot by 37 foot single berth
floating dock, 14 foot by 19 foot platform, and a 4 foot by 26 foot walkway.

LEASE TERM:

Ten years, beginning March 1, 2000.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

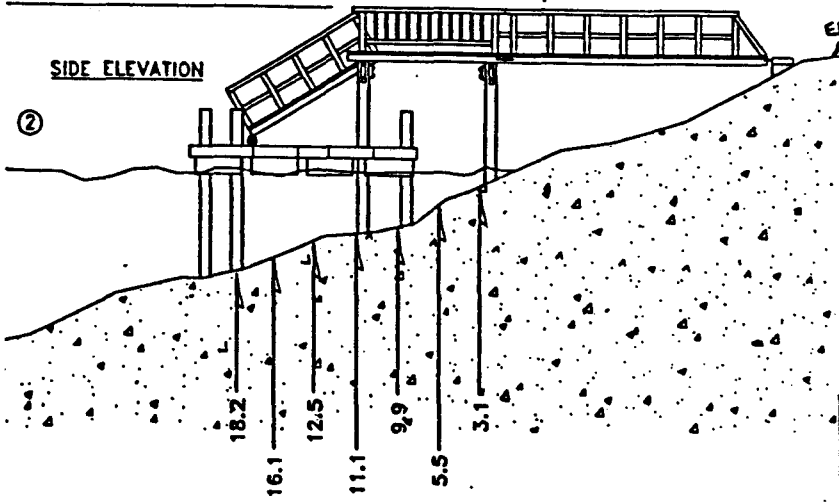
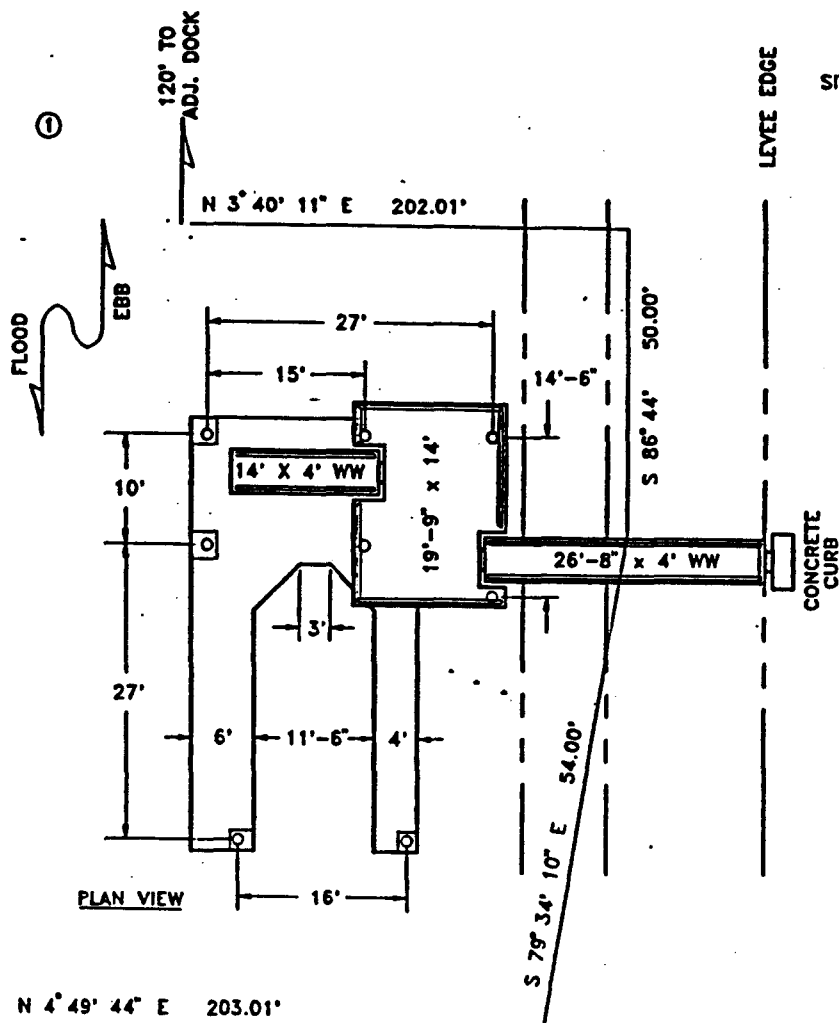

AUTHORIZE ISSUANCE TO ROBERT W. LINVILLE AND LOU ANN M. LINVILLE OF A TEN-YEAR RECREATIONAL PIER LEASE, BEGINNING MARCH 1, 2000, FOR CONTINUED USE AND MAINTENANCE OF AN EXISTING SINGLE BERTH FLOATING DOCK, PLATFORM, AND WALKWAY ON THE LAND SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; NO MONETARY CONSIDERATION PURSUANT TO PUBLIC RESOURCES CODE SECTION 6503.5; LIABILITY INSURANCE IN THE AMOUNT OF NO LESS THAN \$300,000.

Area to be leased lies directly beneath dock and walkway, plus a necessary use area 10 feet in width around the entire dock and walkway. Excepting therefrom any portion lying above the ordinary high water mark.

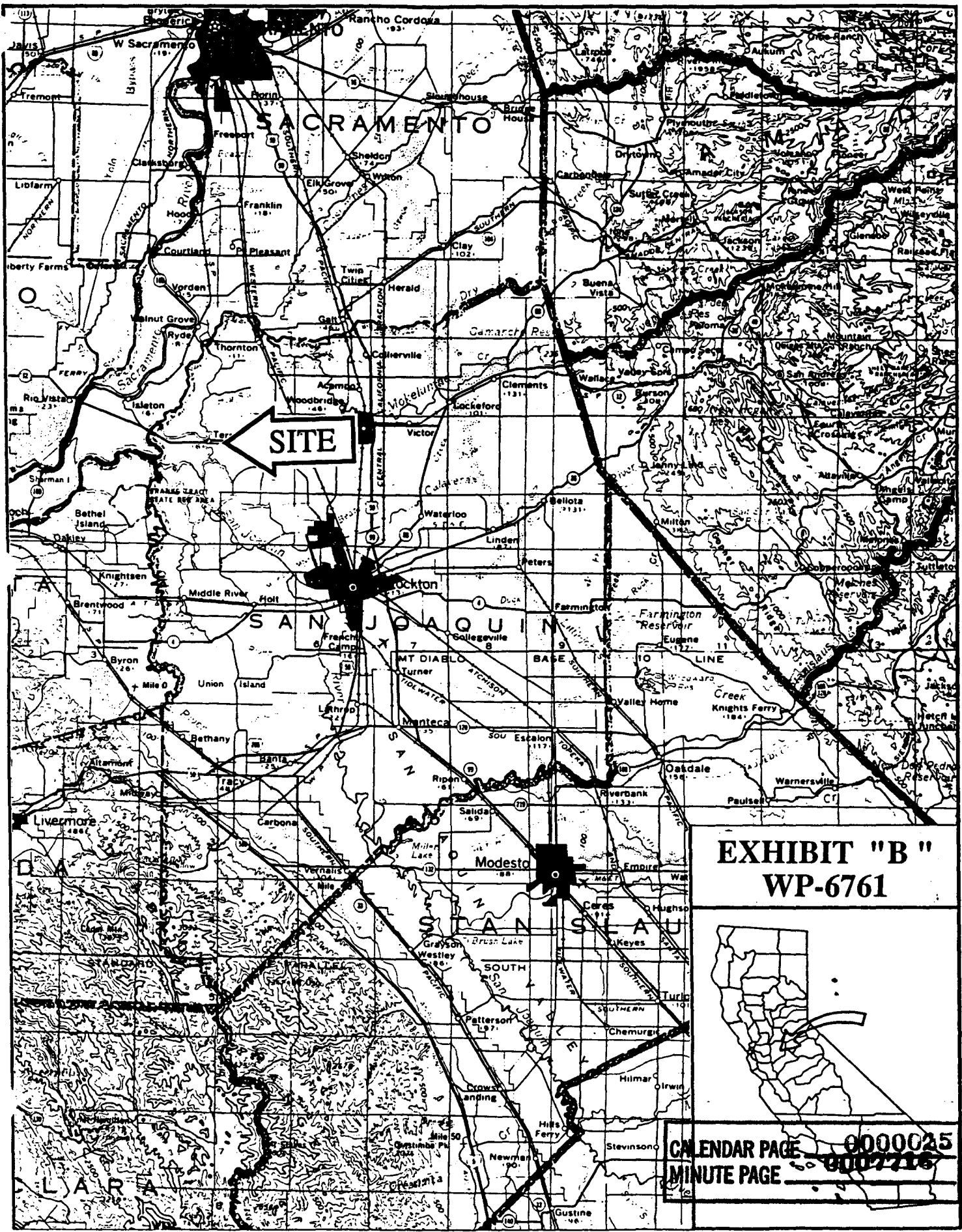
