ACCEPTANCE OF A QUITCLAIM DEED AND TERMINATION OF PUBLIC AGENCY PERMIT

LESSEE:

County of Lassen County Administration Building 707 Nevada Street Susanville, CA 96130

Department of Fish and Game Wildlife Conservation Board 1416 9th Street Sacramento, CA 95814

AREA, LAND TYPE, AND LOCATION:

8.65 acres, more or less, of sovereign lands in Eagle Lake, near Susanville, Lassen County.

AUTHORIZED USE:

Construction and maintenance of a boat launching ramp as described in the attached Exhibit A.

LEASE TERM:

49 years, beginning July 1, 1976, and subsequently amended.

CONSIDERATION:

No monetary consideration. The consideration to the California State Lands Commission for granting this lease was the use and benefit to the public; provided, however, that the Commission shall have the right to assess the lessee a monetary rent for any reporting period in which revenues, derived from or attributable to use of the facilities under lease, exceed expenses of operating, maintaining or improving the facilities.

OTHER PERTINENT INFORMATION:

- 1. On April 28, 1976, the California State Lands Commission approved Public Agency Permit PRC 5112.9 authorizing construction and maintenance of a boat launching ramp in Eagle Lake, Lassen County for a term of 49 years beginning July 1, 1976.
- 2. In September of 1999, the California Department of Fish and Game and the County of Lassen agreed to transfer operation of the boat launching ramp to the Spalding Community Services District.
- 3. The Spalding Community Services District has submitted an application to the California State Lands Commission requesting approval of a General Lease Public Agency Use, authorizing uses which include maintenance of the existing boat launching ramp for a term of 20 years beginning April 1, 2000. This Quitclaim is being tendered to facilitate the issuance of a lease to Spalding Community Services District.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by the CEQA and the State CEQA Guidelines.
 - Authority: Public Resources Code section 21065 and Title 14, California Code of Regulations, section 15378.
- 5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
