San Joaquin River Parkway and Conservation Trust, Inc. 1550 East Shaw Avenue, Suite 114 Fresno, California 93710

AREA, LAND TYPE, AND LOCATION:

Sovereign lands lying below the ordinary low water mark in the San Joaquin River, at Camp Pashayan and Riverside Golf Course, near Herndon, Fresno county.

AUTHORIZED USE:

Planting, maintenance and monitoring of riparian habitat.

LEASE TERM:

Ten years, beginning April 1, 2000.

CONSIDERATION:

The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

SPECIFIC LEASE PROVISIONS:

Insurance:

\$1,000,000 Combined Single Limit Coverage.

OTHER PERTINENT INFORMATION:

- 1. Applicant has a right to use the uplands adjoining the lease premises.
- 2. The restoration projects are a joint venture between the Applicant and the Wildlife Conservation Board. The Camp Pashayan revegetation project involved the installation of a temporary irrigation system, removal of heavily compacted roads and planting of approximately 900 native trees

and shrubs. Species include Blackberry (*Rubus ursinus*), Wild rose (*Rosa californica*), Willow (*Salix sp.*), Cottonwood (*Populus freemontii*), Oregon Ash (*Fraxinus latifolia*), Sycamore (*Platanus racemosa*), Buttonwillow (*Cephalanthus occidentalis*), Alder (*Alnus rhombifolia*), Elderberry (*Sambucus mexicana*) and Valley Oak (*Quercus lobata*). Monitoring and maintenance will include weeding, maintenance of the irrigation system, occasional replanting of unsuccessful trees or shrubs, and removal of the temporary drip irrigation system when the plants are established.

The Riverside Golf Course restoration project involved the removal of debris and seed collection for plant propagation, removal of exotic species, and planting of native species. Species include Willow (Salix *sp.*), Cottonwood (*Populus freemontii*), Oregon Ash (*Fraxinus latifolia*), Sycamore (*Platanus racemosa*), Elderberry (*Sambucus mexicana*), and Valley Oak (*Quercus lobata*). Ongoing monitoring of this project will also occur. This restoration site is in close proximity to the site of a proposed parkway trail (Lewis S. Eaton Trail) for which the applicant, along with the City of Fresno, recently applied for funding. Trail uses will be compatible with restoration activities and will educate the public about the benefits of restoration through interpretive signs.

A component of both projects will be an effort to educate the public on the values of the natural ecosystem of the San Joaquin River and the benefits to the human community. The project is expected to benefit a large number of plant, animal and fish species that are known to use the San Joaquin River and adjacent riparian areas on a year-round or seasonal basis.

3. Camp Pashayan Restoration Project

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff CONCURS WITH THE CITY OF Fresno, the Lead Agency that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 8, Actions by Regulatory Agencies for Protection of the Environment; Title 14, California Code of Regulations, section 15308.


