- 2. The Byxbee Landfill Park is a 146-acre site, once used as a sanitary landfill operation. The landfill is being converted into a phased passive park development. This Phase IIB will entail the construction of a final cover over the PHASE IIB landfill surface and will encompass approximately 23 acres. The Lessee proposes to amend the lease description to include Phase IIB as described in Exhibit A-1 and shown on Exhibit A-2 attached.
- 3. A Negative Declaration was prepared and adopted for this project by the city of Palo Alto. The California State Lands Commission's staff has reviewed such document.


