RECREATIONAL PIER LEASE

APPLICANT:

Sidney J. Hendricks
6614 Lakeville Road
Petaluma, California 95954

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Petaluma River, near the city of Petaluma, Sonoma County.

AUTHORIZED USE:

Construction, use, and maintenance of 6 foot by 105 foot walkway, a 16 foot by 16 foot boat storage pad, a 32 inch by 26 foot gangway, and a 50 foot by 10 foot floating boat dock.

LEASE TERM:

Ten years, beginning September 20, 2000.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Applicant qualifies for a Recreational Pier Lease because the Applicant is a natural person who has improved the littoral land with, and uses the upland for, a single-family dwelling. Applicant has submitted applications to the Army Corps of Engineers and the San Francisco Bay Conservation and Development Commission. Construction may not commence until approvals are obtained from both agencies. Also, Applicant is expressly prohibited from constructing the proposed facilities unless he has

submitted a Streambed Alteration Agreement with the California Department of Fish and Game or a statement from the California Department of Fish and Game that a Streambed Alteration Agreement is not required for this project.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Facilities; Title 2, California Code of Regulations, section 2905 (c)(1).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

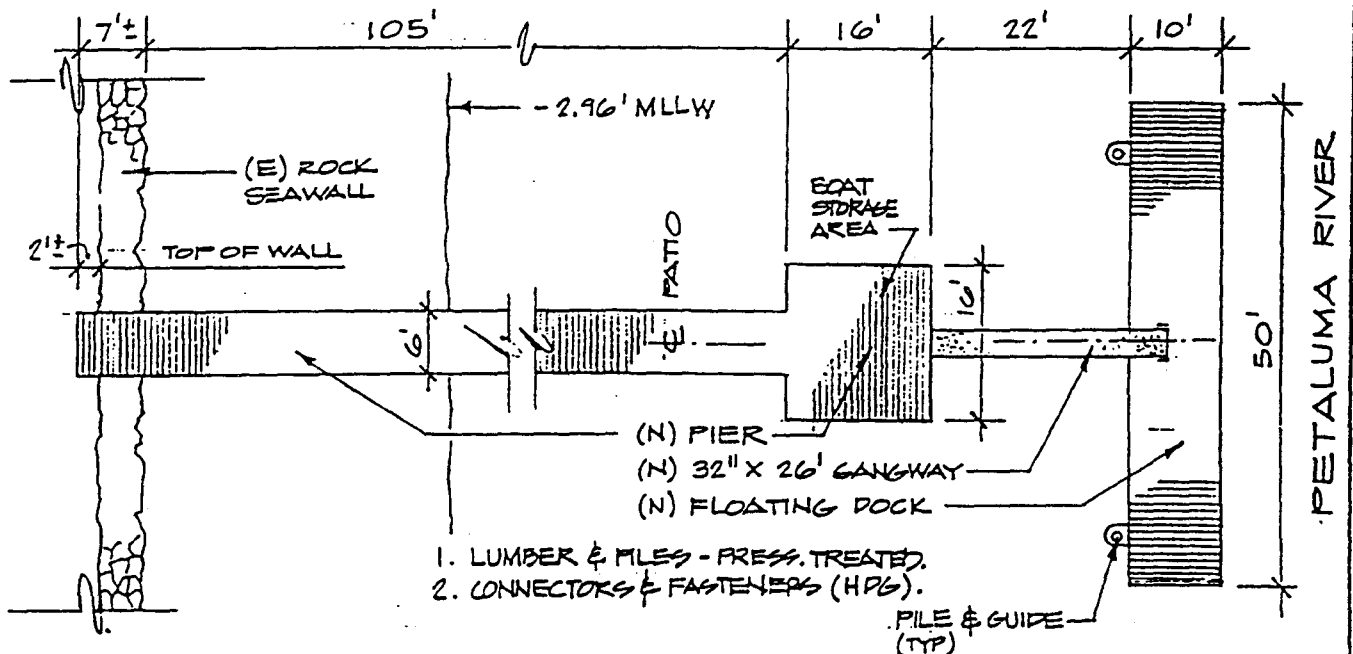
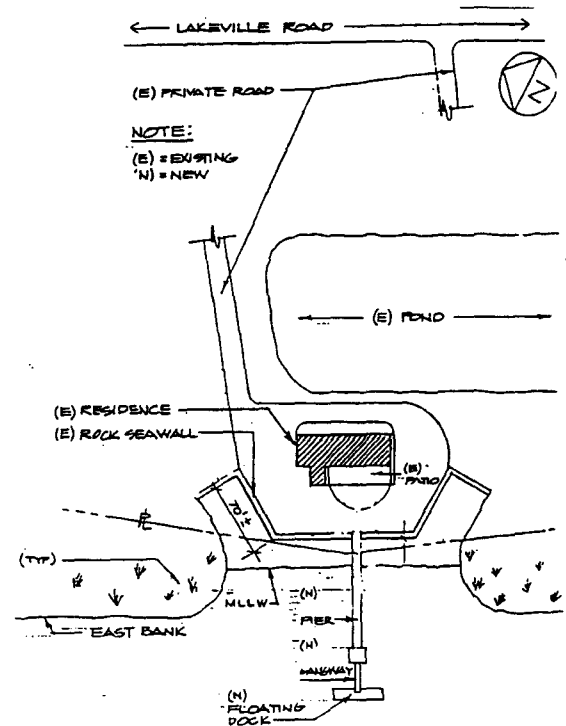
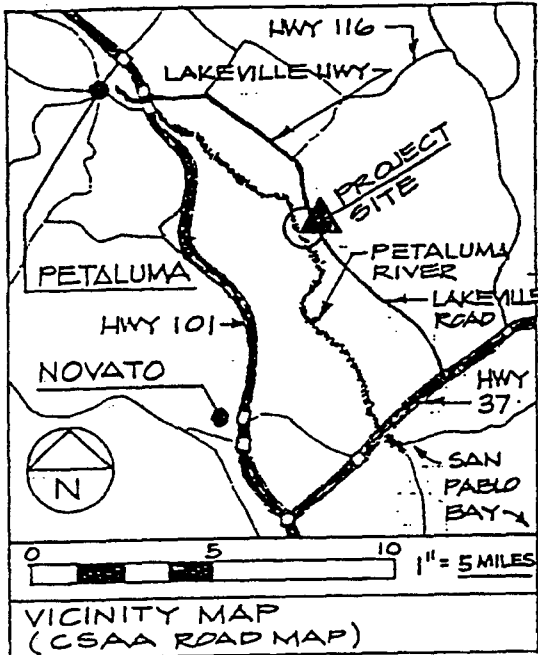
