AREA, LAND TYPE, AND LOCATION:

Sovereign lands in San Diego Bay, City of San Diego, San Diego County.

AUTHORIZED USE:

Construction and maintenance of an eight-inch diameter High-Density Polyethylene pipeline for the receipt, conveyance and discharge of groundwater dewatering effluent.

LEASE TERM:

25 years, beginning September 1, 2000.

CONSIDERATION:

The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance: Combined single limit coverage of \$1,000,000.

OTHER PERTINENT INFORMATION:

- 1. Applicant has a right to use the uplands adjoining the lease premises.
- 2. Applicant is requesting that the Commission authorize the issuance of a Public Agency Lease in conjunction with the proposed construction of a new outfall to receive, convey and discharge groundwater dewatered effluent into San Diego Bay from the Convention Center. Originally, eight

dewatering pumps were installed in the lower level of the Convention Center Parking Structure for groundwater dewatering purposes. The groundwater dewatering effluent was collected, discharged into the storm drain system and then discharged into San Diego Bay at three existing discharge points along the shoreline.

- 3. The new outfall would eliminate the need for the groundwater effluent to be discharged into the storm drain system. In addition, the new outfall would eliminate the need for the three existing discharge points along the shoreline, would allow for compliance with stricter water quality standards should they be adopted in the future, and provide for the ability for the future extension of the outfall diffuser/discharge point further into the Bay if necessary. The proposed outfall will connect to the existing pumping/plumbing system and will be buried onshore along Marina Park Way and within Embarcadero Marina Park South. Approximately 300 feet of pipeline will be buried offshore in a five-foot deep trench within the Bay. An extendible diffuser will be located at the end of the pipeline at a depth of approximately 34-38 feet. The Commission's leasing jurisdiction covers that portion of the outfall that extends beyond the pierhead line.
- 4. A Negative Declaration was prepared and adopted for this project by the City of San Diego. The Commission's staff has reviewed such document.
- 5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.






