#### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Huntington Harbour, Huntington Beach, Orange County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing boat dock as shown on Exhibit A attached.

#### LEASE TERM:

Ten years, beginning September 1, 2000.

#### OTHER PERTINENT INFORMATION:

On December 7, 1995, the Commission authorized a Recreational Pier Lease with B. Casey Yim. That lease will expire on February 10, 2001. On June 3, 1998, B. Casey Yim deeded the littoral land to Alicia Dose. Applicant qualifies for a Recreational Pier Lease because the Applicant is a natural person who has improved the littoral land with, and uses the upland for, a single-family dwelling. Applicant is now applying for a new Recreational Pier Lease.




