ACCEPTANCE OF QUITCLAIM OF EASEMENT

PARTY:

San Diego Gas & Electric Company 8316 Century Park Court San Diego, California 92123

AREA, LAND TYPE, AND LOCATION:

Sovereign public trust lands adjacent to Batiquitos Lagoon, near Carlsbad, San Diego County.

BACKGROUND:

- San Diego Gas and Electric Company (SDG&E) maintained utility facilities across lands that were quitclaimed to the State by Pacific Rim Land Associates Limited Partnership in 1988, pursuant to a title settlement agreement AD 75. The Commission accepted these lands subject to SDG&E's existing utility easement. As part of the Saxony Pump Station Rehabilitation Project, SDG&E has relocated its utility facilities to the south side of La Costa Avenue in Carlsbad, and is prepared to relinquish its easement to the Commission.
- 2. The Leucadia County Water District (District) is proposing to construct an access road at this location in order to access their pump station improvements. The Commission authorized the issuance of a Public Agency Lease (Lease No. PRC 8053.9) to the District at its meeting on December 16, 1998, for a paved truck turnaround and pump station improvements associated with the Saxony Pump Station Rehabilitation Project. A 12-foot wide access road was included as part of the original project description for the Saxony Pump Station Rehabilitation Project, for which a Mitigated Negative Declaration was adopted by the Lessee on July 15, 1998. However, due to an oversight the area was not included in the legal description in Lease No. PRC 8053.9. Pursuant to Calendar Item C47 that follows, staff is requesting that the Commission amend

Lease No. PRC 8053.9 to accommodate the construction and maintenance of the access road.

The sovereign public trust lands involved in this transaction are part of a lease to the California Department of Fish and Game (DFG) for management as part of the Batiquitos Lagoon Ecological Reserve (Lease No. PRC 7242.9). Commission staff has consulted with DFG staff and believes that the acceptance of the Quitclaim of Easement, and the District's construction and maintenance of the access road will not be inconsistent or incompatible with DFG's operations under Lease No. PRC 7242.9.

- 3. Staff required the District to conduct a hazardous waste/materials assessment of the easement area being vacated by SDG&E. That assessment concluded that the site had not been adversely impacted by hazardous waste or materials. Commission staff has reviewed that assessment and is satisfied with the conclusions reached therein.
- 4. Pursuant to the Commission delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by the CEQA and the State CEQA Guidelines.




