**DREDGING LEASE**

**APPLICANT:**

Crescent City Harbor District  
101 Citizens Dock Road  
Crescent City, CA 95531

**AREA, LAND TYPE, AND LOCATION:**

Maintenance dredging in the Crescent City Harbor, near Crescent City, Del Norte County.

**AUTHORIZED USE:**

Maintenance dredging of a maximum of 10,000 cubic yards of material annually in the Crescent City Harbor. The dredged material will be disposed of at the Del Norte County Landfill.

**LEASE TERM:**

Five years, beginning September 1, 2000.

**CONSIDERATION:**

No royalty will be charged as the project will result in a public benefit. A royalty of a minimum of \$0.25 per cubic yard shall be paid for any material sold or used for any private benefit or commercial sale purposes.

**OTHER PERTINENT INFORMATION:**

1. The project is located on lands granted to the Crescent City Harbor District, pursuant to Chapter 1510, Statutes of 1963, with minerals reserved to the State. The Crescent City Harbor District is applying for a Dredging Lease.
2. A Negative Declaration was prepared and adopted for this project by the county of Del Norte. The California State Lands Commission's staff has reviewed such document.

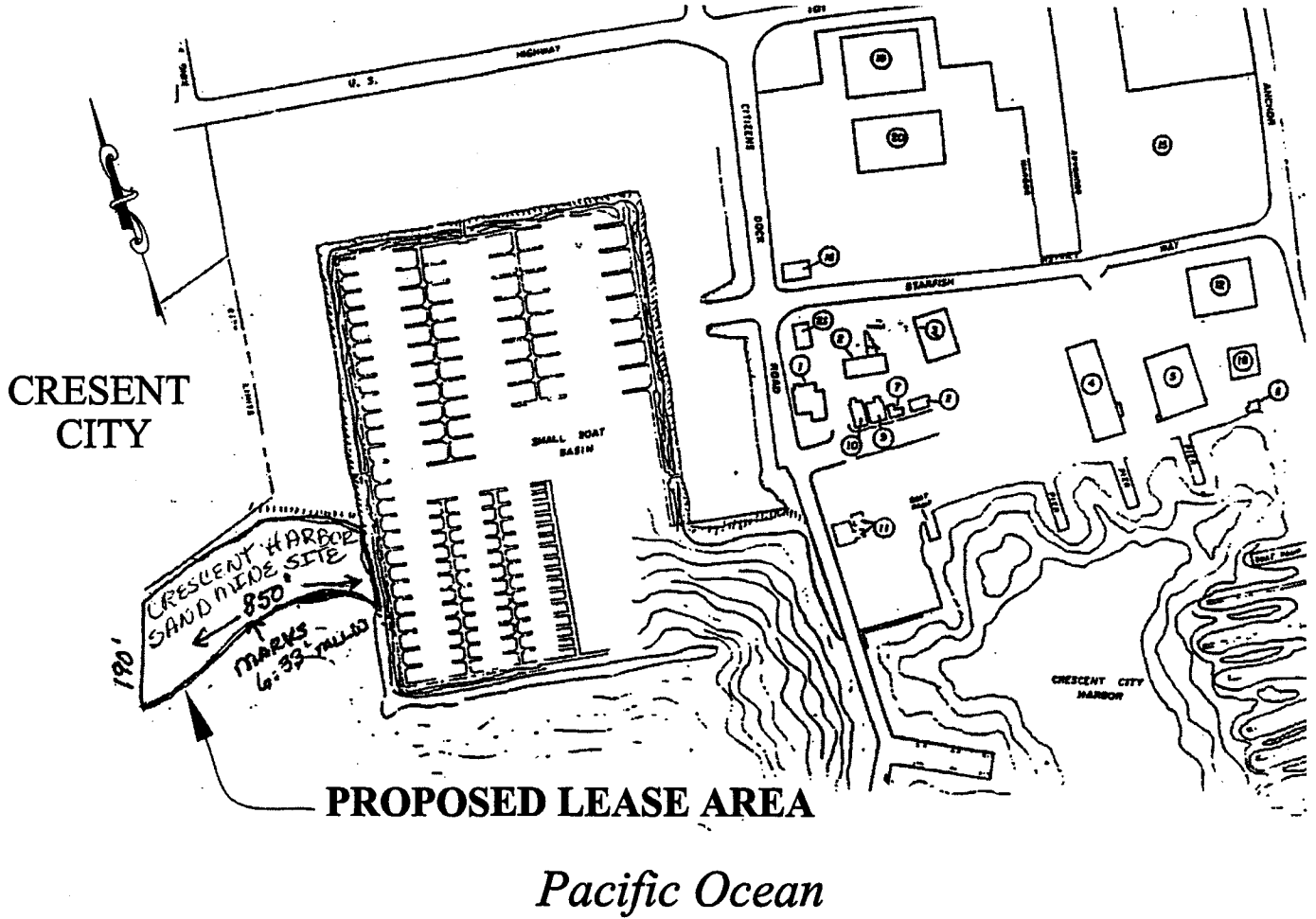

THE DREDGED MATERIAL WILL BE DISPOSED AT THE DEL NORTE COUNTY LANDFILL; SUCH PERMITTED ACTIVITY IS CONTINGENT UPON APPLICANT'S COMPLIANCE WITH APPLICABLE PERMITS, RECOMMENDATIONS, OR

# LOCATION MAP

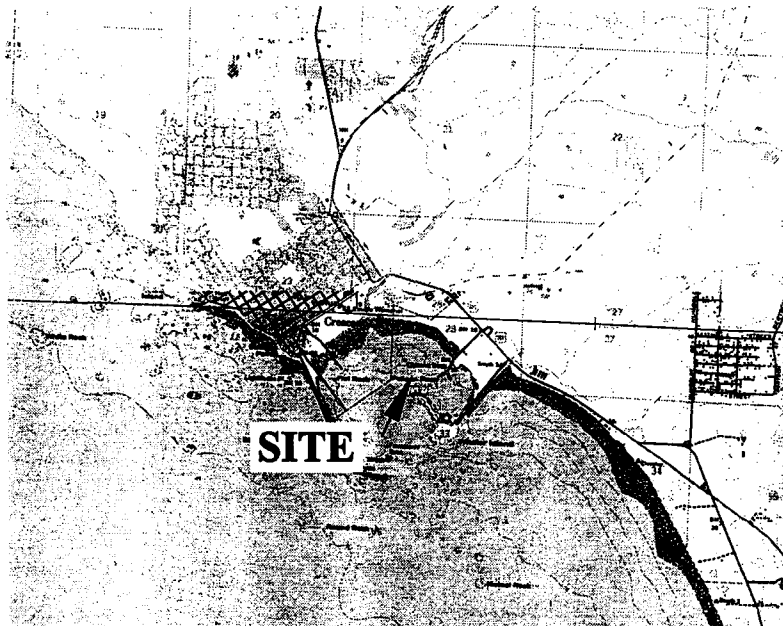
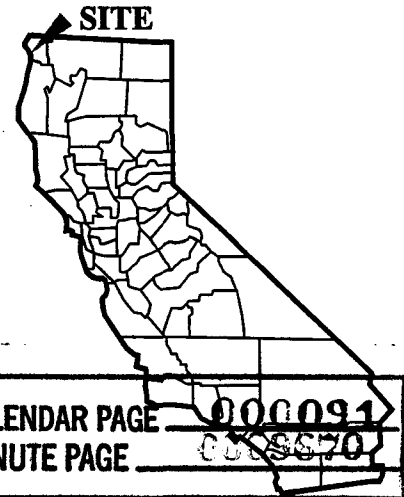
