**GENERAL LEASE - RECREATIONAL USE**

**APPLICANT:**

Hubert K. Griesbach

**AREA, LAND TYPE, AND LOCATION:**

0.04 acres, more or less, of sovereign lands in the Sacramento River, in the town of Walnut Grove, Sacramento County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing floating boat dock and ramp.

**LEASE TERM:**

Ten years, beginning January 31, 2002.

**CONSIDERATION:**

\$225 per year; with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

**SPECIFIC LEASE PROVISIONS:**

Combined single limit coverage of no less than \$500,000.

**OTHER PERTINENT INFORMATION:**

1. Applicant owns the upland which is not developed with a single family residence adjoining the lease premises.
2. A General Lease - Recreational Use was issued to George Warren effective January 31, 1992 thru January 30, 2002, for the installation and use of two recreational boat docks, four pilings, and ramps, previously covered under PRC 7604.1. George Warren has since sold his two

upland properties. Hubert K. Griesbach owns APN 142-0097-026 and is now applying for the use of one existing boat dock.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

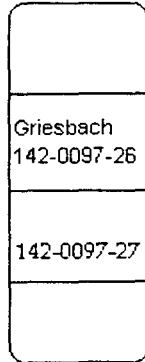

GRIESBACH OF A GENERAL LEASE-RECREATIONAL USE, BEGINNING JANUARY 31, 2002, FOR A TERM OF TEN YEARS, FOR A FLOATING BOAT DOCK AND A RAMP ON THE LAND SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; ANNUAL RENT IN THE AMOUNT OF \$225, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENT PERIODICALLY DURING THE LEASE TERM, AS PROVIDED IN THE LEASE; COMBINED LIABILITY INSURANCE OF NO LESS THAN \$500,000.

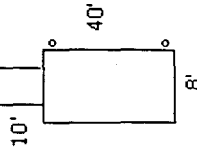

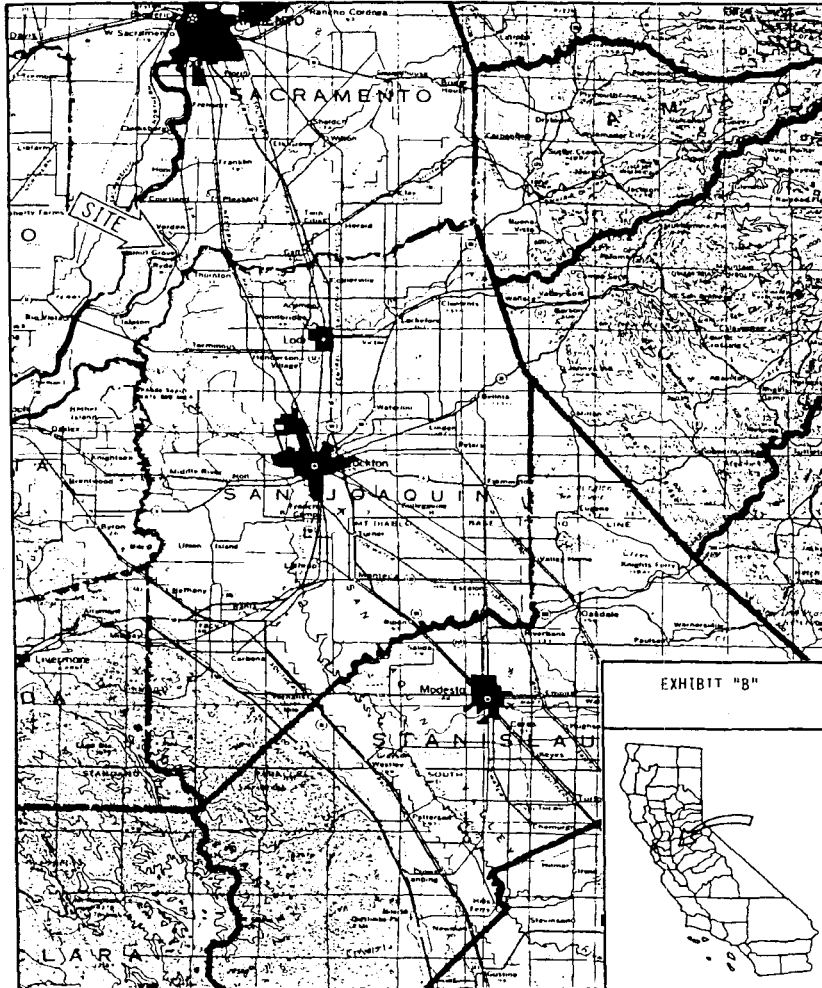
