LESSEE:

Basil C. Pearce, as an individual, and Basil C. Pearce as Trustee of the Virginia Pearce Trust

AREA, LAND TYPE, AND LOCATION:

0.05 acre, more or less, of sovereign lands in Lake Tahoe, Cedar Flat, Placer County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier and boathouse as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning March 1, 1997.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term for an existing pier and boathouse. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$425 per year, effective March 1, 2002.

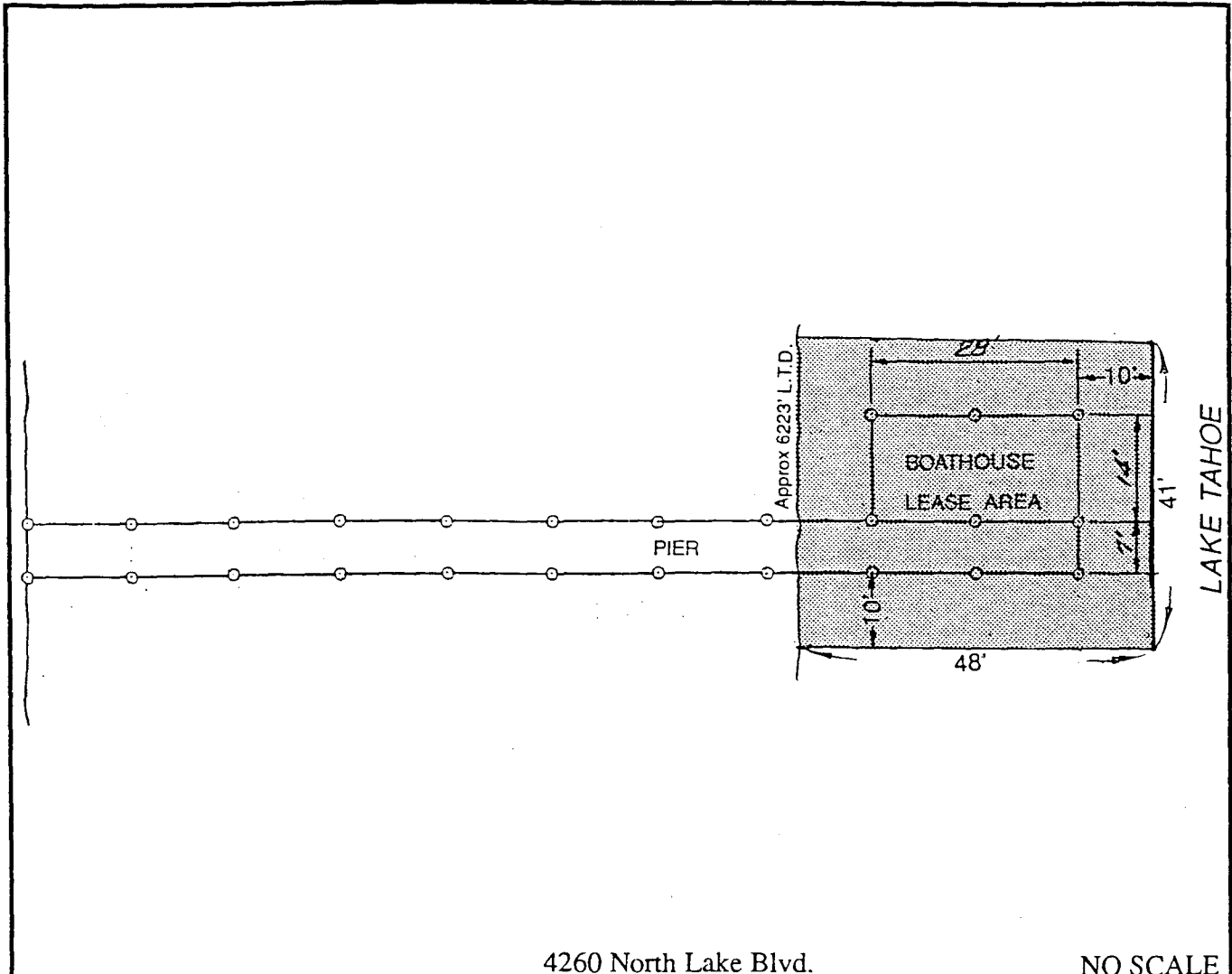

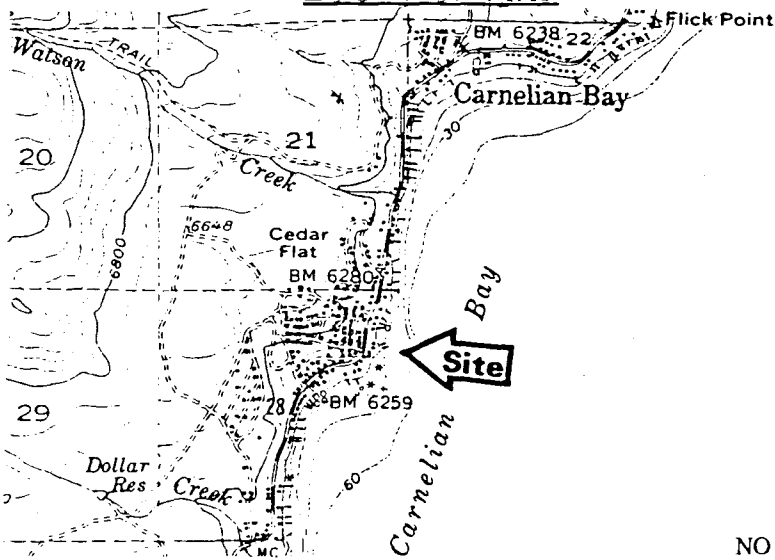

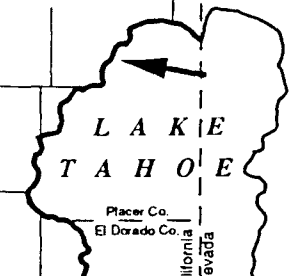
NO SCALE
