Sovereign lands in the Sacramento River, near Walnut Grove, Sacramento County.

AUTHORIZED USE:

Continued use and maintenance of a floating boat dock, access ramp, and landing platform.

LEASE TERM:

Ten years, beginning November 1, 2002

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. On May 23, 1985, the Commission approved a Recreational Pier Lease to John P. Mendonca, Sr. and Joanne C. Mendonca. That lease has now expired. The upland property was subsequently deeded to William F. Saiers. William F. Saiers is now applying for new Recreational Pier Lease. Applicant qualifies for a Recreational Pier Lease because the applicant is a natural person who has improved the littoral land with, and uses the upland for, a single-family dwelling.


