Sovereign lands in Lake Tahoe, near Tahoe City, Placer County.

Retention of two existing mooring buoys.

LEASE TERM:

Ten years, beginning February 1, 2003.

This lease is conditioned on the Applicants obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years after the adoption of the Lake Tahoe Shorezone Amendments-Draft Environmental Impact Statement (EIS) and approval of the ordinances based on the EIS.

1. Applicant qualifies for a Recreational Pier Lease because the Applicant is a natural person who has improved the littoral land with, and uses the upland for, a single-family dwelling. Applicant is now applying for a new Recreational Pier Lease for two existing mooring buoys not previously authorized by the Commission.






