#### **DREDGING LEASE**

#### APPLICANT:

City of Suisun City 701 Civic Center Blvd. Suisun City, CA 94585

## AREA, LAND TYPE, AND LOCATION:

Sovereign lands located at Suisun Slough at Suisun City Marina, Solano County.

## **AUTHORIZED USE:**

Maintenance dredge a maximum 21,000 cubic yards of material from Suisun Slough at Suisun Marina, Solano County. Dredged sediments will be placed at the U.S. Army Corps of Engineers designated upland Disposal Site at Pierce Island.

#### LEASE TERM:

February 18, 2003 through December 1, 2007.

#### CONSIDERATION:

No royalty will be charged; \$0.25 per cubic yard will be charged for any material used for private benefit or commercial sale purposes.

#### OTHER PERTINENT INFORMATION:

- 1. This project is part of a larger dredging project (175,000 cubic yards) at Suisun Marina. No lease is required for the dredging of 154,000 cubic yards that will occur on that portion of land that is outside of State ownership.
- 2. On December 9, 1985, the San Francisco Bay Conservation and Development Commission (BCDC) granted Permit #M85-87, amendment no. 6 under its certified program. (Title 14, California

NO ROYALTY SHALL BE CHARGED, AS THE PROJECT WILL RESULT IN A PUBLIC BENEFIT: \$0.25 PER CUBIC YARD SHALL BE CHARGED FOR ANY MATERIAL USED FOR PRIVATE BENEFIT OR FOR COMMERCIAL SALE PURPOSES.




EXHIBIT "A"


