the Commission approved a 20-year lease, which will expire on June 30, 2018.

- 3. The Assignee is an optional private membership club formed in 1962 to administer the recreational facilities created by the developer of Agate Bay Shores Subdivision, Agate Bay Properties, Inc. (Lessee/Assignor). The membership is limited to property owners of the upland development. Agate Bay Pier and Swim Club (Club) was a "DBA" of the Lessee/Assignor until February 9, 2000 when the Club incorporated as a separate entity in anticipation of the acquisition of the recreational facilities. In addition to the recreational facilities located on the lease premises, the Club is acquiring the upland recreational facility sites and related equipment.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines [Title 14, California Code of Regulations, section 15060(c)(3)], the staff has determined that this activity is not subject to the provisions of the CEQA because it is not a "project" as defined by the CEQA and the State CEQA Guidelines.




# **SITE MAP**
