AMENDMENT OF GENERAL LEASE - PUBLIC AGENCY USE

LESSEES/APPLICANTS:

Tahoe City Public Utility District and California Department of Fish and Game, acting through the Wildlife Conservation Board

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near Tahoe City, Placer County.

AUTHORIZED USE:

Operation and maintenance of an existing pier, boat ramp, and existing fill.

PROPOSED AMENDMENT:

Amend the lease to authorize the addition of a temporary float section to the existing pier and installation of a temporary boat ramp extension.

LEASE TERM:

49 years, beginning January 16, 1979.

CONSIDERATION:

The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

SPECIFIC LEASE PROVISIONS:

Insurance:

Combined single limit coverage of \$1,000,000.

OTHER PERTINENT INFORMATION:

 On June 27, 1979, the Commission authorized a General Permit - Public Agency Use with the Tahoe City Public Utility District and the California Department of Fish and Game, acting through the Wildlife Conservation

Board. That permit will expire on January 15, 2028. On April 24, 1980, the Commission authorized an amendment to this permit for construction of an extension to the pier. A second amendment was authorized on April 24, 2001, for the expansion, relocation and reconstruction of the pier.

- 2. Due to the current low water level of Lake Tahoe, concerns regarding the safety of the boating public on the lease premises have arisen. During this period of low water, an 18-inch drop-off at the end of the existing boat ramp has developed creating a hazardous situation for boaters when they launch and enter boats from this area. In addition, the existing pier is almost inaccessible to boats at this time. As a result, Tahoe City Public Utility District and the California Department of Fish and Game, acting through the Wildlife Conservation Board, are now applying for a third amendment to authorize the addition and use of a temporary float section to the existing pier and installation of a temporary boat ramp extension. These facilities would be used when the lake level falls below elevation 6226.10 feet and, as the facilities are not necessary when the lake is at a normal level, the facilities will be removed when the lake level exceeds elevation 6226.10. The Lessees are also proposing the use of the temporary facilities as they wish to immediately remedy the public safety situation prior to the upcoming boating season.
- 3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA under the general rule that the CEQA applies only to projects which have the potential for causing a significant effect on the environment. The staff believes, based on the information available to it, that there is no possibility that this project may have a significant effect on the environment.

Authority: Title 14, California Code of Regulations, section 15061 (b) (3).

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.







EXHIBIT B Pier Lease Area Description
