Scanvik, L.P., a California limited partnership

ASSIGNEES:

Rumsey GPF I, LLC, and Morton L. Friedman and Marcine Friedman, dba Triangle Partners

AREA, LAND TYPE, AND LOCATION:

0.38 acres, more or less, of sovereign lands located in the Sacramento River, city of West Sacramento, Yolo County.

AUTHORIZED USE:

Continued use and maintenance of an existing wharfage for industrial purposes, including a wharf and six pilings.

LEASE TERM:

Thirty years, beginning August 21, 1982.

CONSIDERATION:

\$2,025 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

OTHER PERTINENT INFORMATION:

- 1. Assignee owns the uplands adjoining the lease premises.


