CONSIDER APPROVAL OF A DEFERMENT OF DRILLING OBLIGATION, OIL AND GAS LEASE NO. PRC 7976.1, NURSE SLOUGH, SOLANO COUNTY

AREA, TYPE LAND AND LOCATION:

Oil and Gas Lease No. PRC 7976.1 (Lease) contains 42 acres in the bed of Nurse Slough in Solono County.

BACKGROUND:

Oil and Gas Lease No. PRC 7976.1 was issued on July 11, 1997, to McFarland Energy Company (80%) and Santa Barbara Resources, Inc. (20%). McFarland directionally drilled the Kirby Hills 24-1 Well under Nurse Slough in August 1997. The Kirby Hills 24-1 had significant shows of natural gas, but was considered uncommercial and was plugged and abandoned. One Hundred percent (100%) of McFarland Energy Company's 80 percent (80%) interest in PRC 7976.1 was assigned to Slawson Exploration Company, Inc. (Slawson) on January 29, 1999. Slawson drilled the B&B #1 Well adjacent to Nurse Slough in June 2001. The well was unproductive and was immediately plugged and abandoned in June 2001. Slawson, by letter of March 8, 2002, requested a one-year extension of the drilling term to negotiate with Towne Exploration Company (Towne) to re-drill

and deepen the B&B #1 Well adjacent to Nurse Slough. On June 18, 2002, the California State Lands Commission approved a one-year extension of the drilling term to July 10, 2003. Slawson, by letter of April 29, 2003, is requesting, citing permitting delays, another one-year extension of its drilling term to July 10, 2004. Slawson's April 29, 2003, letter (Exhibit C attached hereto), states " In line with terms of the May 16, 2002, agreement, had the re-entry been successful, the subject State lease would have been pooled and this will still be the case if Towne proceeds and achieves success with the operation" (pooling of the leased lands, however, is permitted only with the approval of the Commission, which approval is not being sought at this time). Slawson is, and has been, diligently pursuing activities to make PRC 7976.1 a productive lease. Commission staff recommends granting a one-year extension of the drilling term to July 10, 2004.


A parcel of State owned tide and submerged lands lying in the bed of Nurse Slough (Luco Slough) Solano County, California said parcel described as follows:

Based on our March 18. 2002 request, the California State Lands Commission approved a one-year extension of the drilling term for the State Oil and Gas Lease PRC 7976.1, Nurse Slough, Solano County, California.

You will recall that Slawson drilled the B&B #1 well that was plugged and abandoned on June 18, 2001. As provided in letter agreement of May 16, 2002 (copy enclosed), based on their review of the well logs and our proprietary seismic data, Towne Exploration Company intends to deepen the B&B #1.

We understand that Towne was unable to complete this operation last season because of permitting delays. In line with the terms of the May 16 agreement, had the re-entry been successful, the subject State lease would have been pooled in and this will still be the case if Towne proceeds and achieves success with the operation.

We understand that the deepening of this well remains viable for Towne. Timing at this point is unknown but, to protect the State's rights if the well is successful, and in order to allow adequate timing to know the results of the well, we are requesting an additional one-year extension of the drilling term for the captioned lease.

Dear Art:

By letter dated March 18, 2002, Slawson requested a one-year extension of the drilling term for the captioned lease. Recently, you brought to our attention the fact that Towne Operating Company filed a permit to re-enter the B & B #1 well adjacent to the subject lease. Your concern that a well will be located in close proximity to the State lease with no pooling arrangement is hereby acknowledged and addressed in this letter.

Slawson and Towne are in agreement that in the event operations are conducted on the stated well, which results in the establishment of production, all or a portion of State Oil and Gas Lease PRC 7976 will be included in a productive pooled unit and will comprise 7.1% of the pool. The balance of the pooled unit includes lands located on either side of the State Lease that are owned by Slawson and/or Towne.

The establishment of the pool is based upon 3D data. Utilization of 3D data enables us to identify expected natural gas pools prior to drilling. The allocation of production set forth in this letter is based upon a detailed geological and geophysical analysis of the percentage of the total gas pool that is underneath each tract of land in the unit. The surface acreage contribution of pooled tracts will be finalized upon achievement of production and will be designed to result in an exact match to the calculated percentage set forth herein. This approach to pooling ensures a fair sharing of the gas revenues in the event the well is productive.

- 1. Consent to pool California State Oil and Gas Lease, PRC 7976, as set forth herein. A formal Declaration of Pooling will be prepared with final pooling established upon production.
- 2. In the event less than the entire acreage associated with State Oil and Gas Lease, PC 7976 is pooled, Slawson wishes to maintain such leasehold by the extension of the drilling term as requested in our March 18, 2002 letter.
