BACKGROUND:

The Commission's staff advised the then lessee, Tosco Corporation, by letter dated December 23, 1997, that the existing lease would expire December 31, 1999 with one ten-year renewal period remaining. On August 31, 2000, Tosco Corporation executed a purchase and sale agreement with Ultramar Diamond Shamrock Corporation, which the Commission approved at its meeting of January 1, 2002. On January 18, 2002, staff was advised that due to the merger of Ultramar and Valero that the Federal Trade Commission ordered the sale of the Golden Eagle Refinery and other assets (including this leasehold). Tesoro Refining and Marketing Company purchased this leasehold from Ultramar on May 17, 2002.

The Commission approved assignment of this lease to Tesoro at its' December 16, 2002 meeting, with two conditions: 1) submission of an application with six months; and 2) having a complete marine terminal lease application within one year of the approval date. Lessee requests that the submission of the application and the complete application be extended an additional three months because the applicant's application will request new 30-year leases for both the Avon (PRC 3454) and Amorco (PRC 3453) marine terminals.

CONSIDERATION:

\$66,169 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

This lease remains under the terms and conditions of the existing lease until the Commission approves a new lease.

- 3.
