## RETROCESSION OF JURISDICTION OVER A PORTION OF THE NAVAL CONSTRUCTION BATTALION CENTER. PORT HUENEME, VENTURA COUNTY

#### **BACKGROUND:**

The United States exercises partial jurisdiction over the Naval Construction Battalion Center, Port Hueneme, Ventura County. By letter dated October 9, 2002, the Department of the Navy requested that California accept a retrocession of partial jurisdiction over forty-two one hundredths acres of this facility and to establish concurrent legislative jurisdiction. The subject parcel is outside of the perimeter fence of the Base and will be used for sidewalks and road improvements. The Navy and the City believe that the combined police forces of the Navy and the City will provide the best security for children and other persons using the parcel. The Commission acted on that request on April 7, 2003 and accepted the retrocession in Item C34. The Commission's action was recorded in the office of the Ventura County Recorder on April 30, 2003 as document 2003-0144421-00.

#### PRESENT ACTION:

Calendar Item C34 contained a typographical error in the legal description. This Calendar Item corrects that typographical error. All other terms and conditions of the retrocession remain the same.
