DREDGING LEASE

APPLICANT:

Tahoe Keys Property Owners Association 356 Ala Wai Blvd South Lake Tahoe, CA 96150

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, located at Tahoe Keys, El Dorado County.

AUTHORIZED USE:

Maintenance dredging of approximately 3,000 cubic yards of material from the West Channel entrance of Tahoe Keys, as shown on Exhibit A.

LEASE TERM:

One year, beginning December 9, 2003.

CONSIDERATION:

The public health and safety; a royalty of \$0.25 per cubic yard will be charged for any material used for private benefit or commercial sale purposes.

OTHER PERTINENT INFORMATION:

- 1. Applicant owns the upland adjacent to the sovereign lands.
- 2. The California State Lands Commission (Commission) previously approved issuance of a dredging lease on July 10, 1989, for maintenance dredging of the West Channel entrance to Tahoe Keys. The purpose of the proposed project is to dredge a total of 5,400 cubic yards accumulated excess sediment from the inner lagoon and the West Channel entrance in order to maintain the navigable depth. Of the total quantity of material to be dredged, a maximum volume of 3,000 cubic yards will be dredged from the

West Channel entrance that will lower the channel to an elevation of 6217 feet, Lake Tahoe Datum.

- 3. The Applicant has submitted an application to the Commission in order to perform the required maintenance dredging activities. The proposed project will utilize an electrically powered, remotely controlled, cutterhead suction dredge that will operate from the shore. The dredge will operate at an average capacity of approximately 400 cubic yards of dredged material per day. The dredged material will be placed in an upland location for dewatering and then transported via truck to the following approved upland disposal sites, Tahoe Asphalt and the Carson City Landfill.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alterations to Land; Title 2, California Code of Regulations, section 2905 (d)(4).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.






