# **CONTINUATION OF RENT**

#### LESSEE:

GTE California, Inc.

# AREA, LAND TYPE, AND LOCATION:

0.30 acres, more or less, of State School Lands located in Section 21, T1S, R4E, SBM near the city of Morongo Valley, San Bernardino County.

# **AUTHORIZED USE:**

Operation and maintenance of existing overhead and underground telephone lines and power lines.

### **LEASE TERM:**

49 years, beginning May 29, 1969.

## CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$100 per year, effective May 29, 2004.

# OTHER PERTINENT INFORMATION:

1. On June 26, 1969, the Commission authorized a General Lease – Right Of Way Easement to General Telephone Company of California for a term of 49 years covering a pole-line easement for telephone lines and a future 12kV line. The Commission authorized an amendment in September of 1978 to allow for construction and maintenance of buried cables in addition to the aerial cables provided for in the original lease. The easement is for overhead and underground telephone and power lines on approximately 0.30 acres of State School Land located near the city of Morongo Valley. This lease will expire on May 28, 2018.




