#### LESSEE:

Martin Larralde

# AREA, LAND TYPE, AND LOCATION:

Three parcels totaling 768 acres, more or less, of State School Lands located in the Northwest 1/4 and the West 1/2 of the Southwest 1/4 of Section 36, Township 26 South, Range 42 East, MDM, and Section 36, Township 27 South, Range 42 East, MDM, near the towns of Spangler and Ridgecrest, San Bernardino County.

#### AUTHORIZED USE:

Sheep grazing.

#### LEASE TERM:

Ten years, beginning July 27, 1997.

#### **CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$500 per year, effective July 27, 2004.

# **OTHER PERTINENT INFORMATION:**

1. On July 11, 1997, the Commission authorized a General Lease – Grazing Use to Martin Larralde for a term of ten years. The lease is for sheep grazing on three parcels of State School Lands, totaling approximately 768 acres, located near the towns of Spangler and Ridgecrest. This lease will expire on July 26, 2007.
