LESSEE:

AREA, LAND TYPE, AND LOCATION:

0.52 acres, more or less, of tide and submerged lands in Steamboat Slough, near Walnut Grove, Sacramento and Solano Counties.

AUTHORIZED USE:

Continued use and maintenance of an existing six-inch diameter, directionally bored, welded steel, natural gas pipeline.

LEASE TERM:

20 years, beginning June 14, 1999.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$130.00 per year to \$187.00 per year, effective June 14, 2004.

SPECIFIC LEASE PROVISIONS:

Insurance:

\$500,000 Combined Single Limit.

Bond:

\$10,000

OTHER PERTINENT INFORMATION:

1. On June 14, 1999, the Commission issued a twenty-year General Lease-Right of Way Use to Delta Gas Gathering, Inc. for the installation of a sixinch diameter, directionally bored, welded steel, natural gas pipeline.

2. This pipeline was hydro-tested just after construction was completed in 1999. The pipeline's cathodic corrosion protection system uses magnesium anodes at intervals along the pipeline corridor. The annual CP test was performed October 30, 2003, and all pipe-to-soil potentials were normal and consistent with the prior year's reading. The Regional Water Quality Control Board and the Air Resources Board indicated no violations or citations have been levied in the past five years.


