RECREATIONAL PIER LEASE

APPLICANTS:

Ted Constantine and Nicola Constantine

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Sacramento River, adjacent to the Garden Highway, city of Sacramento, Sacramento County.

AUTHORIZED USE:

Continued use and maintenance of an existing covered boat dock and ramp, and construction of a debris deflector.

LEASE TERM:

Ten years, beginning June 1, 2004.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

 On June 19, 1998, the Commission authorized a Recreational Pier Lease with Al Sarti and Erna Sarti. Al Sarti and Erna Sarti have deeded the littoral land to Ted Constantine and Nicola Constantine. Ted Constantine and Nicola Constantine are now applying for a new Receational Pier Lease. Applicants qualify for a Recreational Pier Lease because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling.




