CONTINUATION OF RENT

LESSEE:

Lighthouse Real Estate Consulting, LLC., aka: LREC, LLC a California Limited Liability Corporation

AREA, LAND TYPE, AND LOCATION:

1.685 acres, more or less, of sovereign lands in the Mokelumne River, at Andrus Island, Isleton, Sacramento County.

AUTHORIZED USE:

Use and maintenance of an existing commercial marina that consists of both covered and uncovered berths, side ties, a launch ramp, speed buoys, a restaurant operation, a portion which extends over the subject lease area, and other appurtenances.

LEASE TERM:

30 years, beginning August 1, 1983.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$4,400 per year, effective August 1, 2004.

OTHER PERTINENT INFORMATION:

1. On November 21, 1983, the Commission authorized a General Lease – Commercial Use to Lighthouse Marina and Resort for a commercial marina. Subsequently, the lease was transferred to Lighthouse Real Estate Consulting, LLC. The marina consists of approximately 30 covered and 41 uncovered berths, 3 side ties, a launch ramp and a restaurant.


