**ASSIGNMENT OF LEASE**

**AREA, LAND TYPE, AND LOCATION:**

0.44 acres, more or less, of tide and submerged lands in the San Joaquin River,  
Andrus Island, Sacramento County.

**AUTHORIZED USE:**

Continued use and maintenance of a 16-berth marina with pilings and gangway.

**LEASE TERM:**

20 years, beginning July 19, 1993.

**CONSIDERATION:**

\$1,267 per year, with 0.5% (one-half of one percent) of the total sales price,  
without offset or deduction, derived from boat sales by sublessees of Lessee  
regularly engaged in the business of selling boats as a dealer or as a broker.

**OTHER PERTINENT INFORMATION:**

1. Assignee owns the uplands adjoining the lease premises.
2. On July 19, 1993, the Commission authorized issuance to Joe M. Cantrell, General Lease – Commercial Use No. PRC 7699.1 for a commercial marina. On April 9, 2002, the Commission authorized assignment of this lease from Joe M. Cantrell to Gail M. Frost and Kenneth Eugene Thomas. On September 10, 2004, Bradley H. Smith entered into an agreement to purchase the property. Mr. Smith is now applying for assignment of the lease.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines [Title 14, California Code of Regulations, section 15060(c)(3)], the staff has determined that this activity is not subject to the provisions of the CEQA because it is not a "project" as defined by the CEQA and the State CEQA Guidelines.

Authority: Public Resources Code section 21065 and Title 14, California Code of Regulations, sections 15060 (c)(3) and 15378.

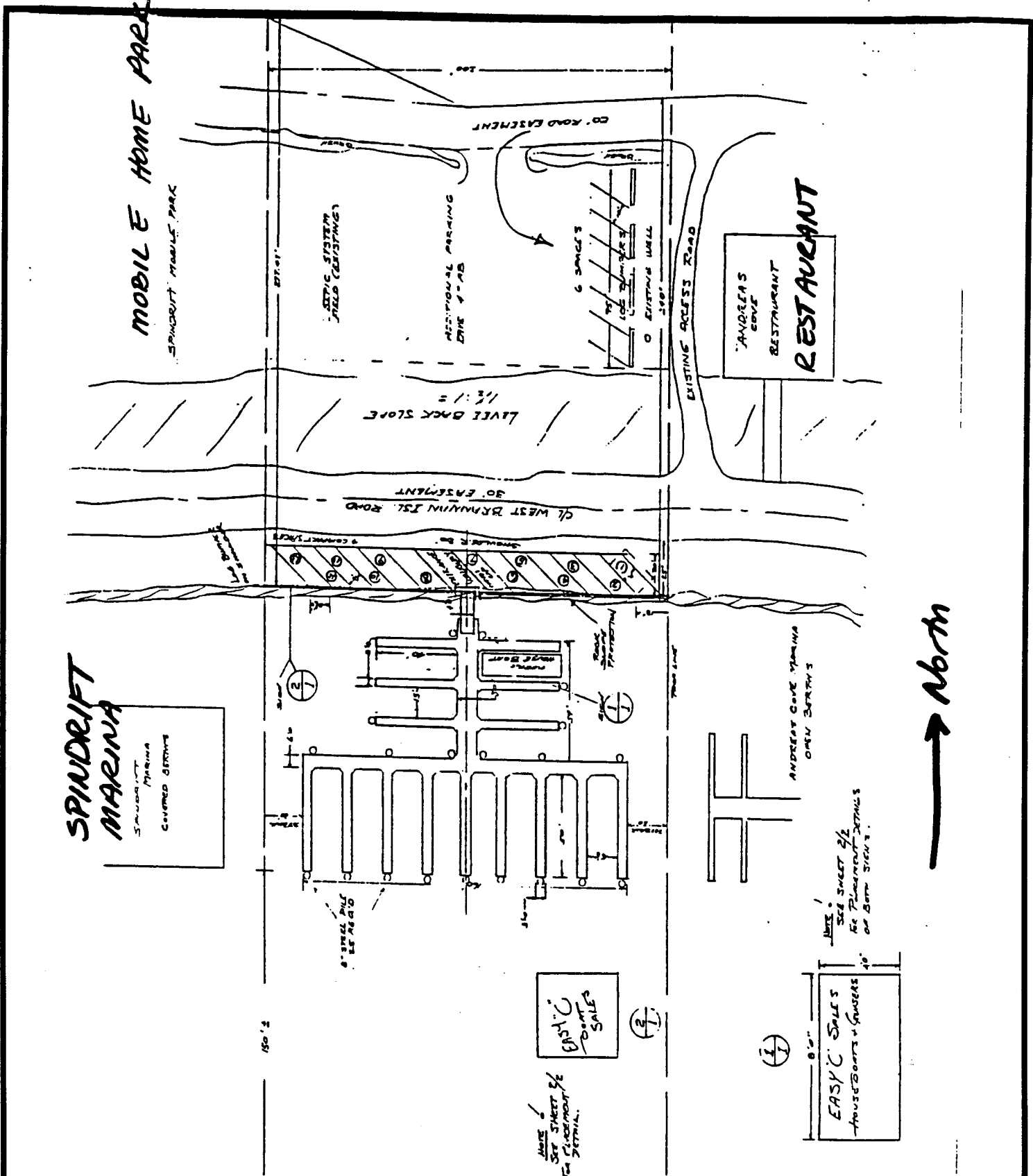

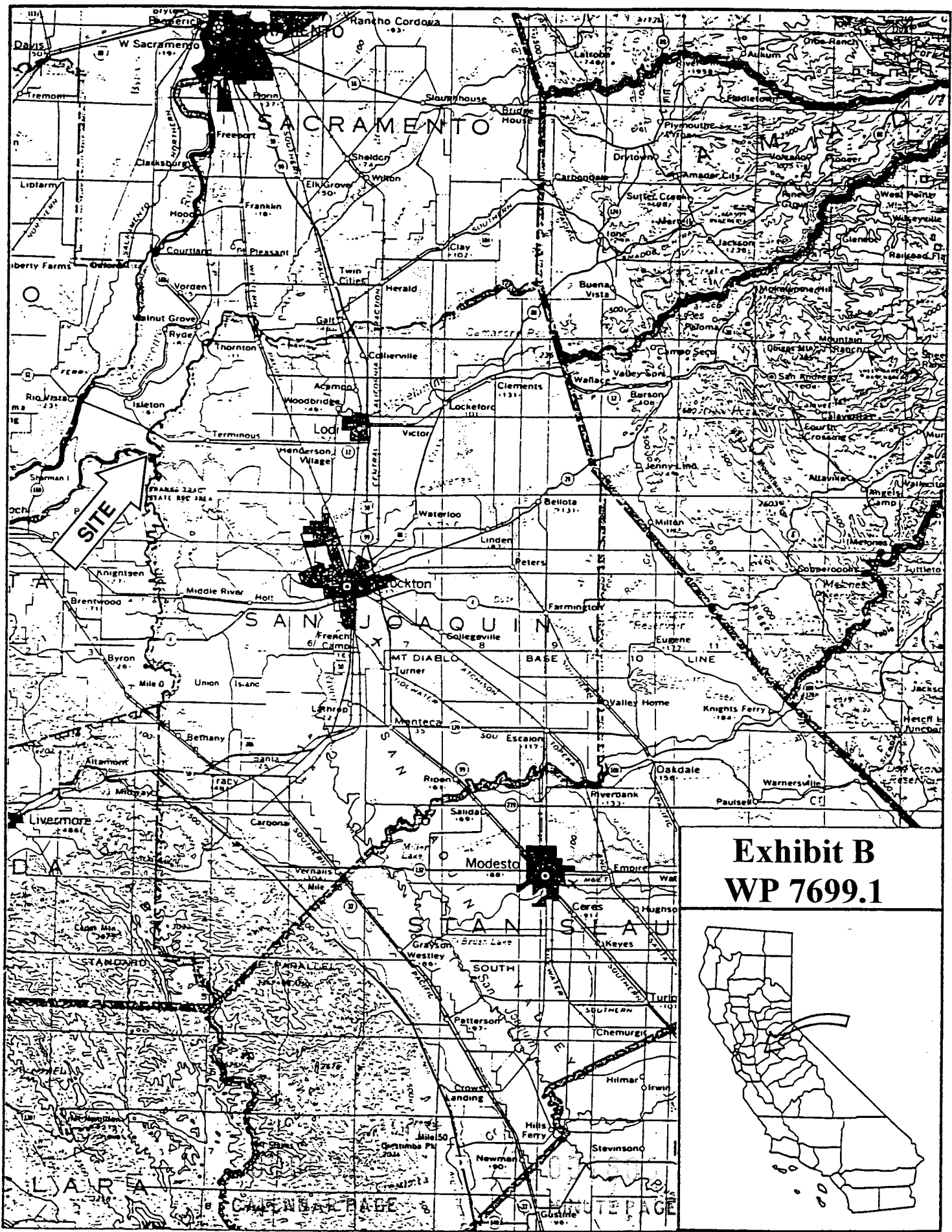
