### AREA, LAND TYPE, AND LOCATION:

Tide and submerged lands in the San Joaquin River, near the city of Antioch, River Mile 7.6, Contra Costa County.

### AUTHORIZED USE:

Continued use and maintenance of an existing fishing pier.

### LEASE TERM:

25 years, beginning July 17, 2004.

### CONSIDERATION:

The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.




