CONSIDER ACCEPTANCE OF THE FULL QUITCLAIM OF OFFSHORE OIL & GAS LEASE NO. PRC 2199.1,
OFFSHORE GAVIOTA AREA
SANTA BARBARA COUNTY, CALIFORNIA

AREA, LAND TYPE, AND LOCATION:

Oil and Gas Lease No. PRC 2199.1 contains approximately 3,840 acres of tide and submerged lands in the vicinity of Gaviota, Offshore Santa Barbara County, California.

BACKGROUND:

Oil and Gas Lease No. PRC 2199.1 (Lease) was originally issued to Humble Oil and Standard Oil of California in July 1958, and has produced over 85 billion cubic feet of gas during its productive life. Through a series of assignments and name changes, the lease (subsurface only) is currently held by Harvest Natural Resources, Inc. (Harvest).

The lease was assigned to Molino Energy Company (predecessor to Harvest), covering the subsurface only, and was the subject of a development plan to drill and produce the lease from an onshore site. An EIR, for development of the offshore gas fields from an onshore drilling and production site, was prepared and certified by the County of Santa Barbara (County) on September 3, 1996. On September 11, 1996, the California Coastal Commission considered and approved an amendment to the Santa Barbara County Local Coastal Plan to allow for the development. The California State Lands Commission (Commission) approved the development plan at a regularly scheduled meeting on July 11, 1997.

The onshore drilling and production site was approximately three acres in size and located within a County designated Consolidated Oil and Gas Planning Area. In 1998, Molino, and its partner, Benton Oil and Gas, drilled an extended reach gas well into the lease. The drilling was difficult and expensive, and although tests showed the presence of gas and condensate, the well was unable to produce at economic levels. The well was plugged and abandoned to current state standards.

Public Resources Code section 6804.1, and Lease Paragraph 5, permit the lessee to make a written quitclaim of all rights under the lease or of any portion of the leased lands comprising a ten-acre parcel or multiple thereof, in a compact form, at any time. The quitclaim is effective when it is filed with the State subject to the continued obligation of the lessee and its surety to pay all accrued rentals and royalties and to abandon all wells drilled on the leased lands.

The Commission's Long Beach office staff received the document "Lease Quitclaim Deed for State Oil and Gas Lease" on October 26, 2004. This document was dated October 25, 2004, and quitclaims back to the State all of the lessee's right, title and interest in the leased lands described in Exhibit A, attached hereto, of Oil and Gas Lease No. PRC 2199.1 dated July 25, 1958.

A review of the Commission's files reveals that no default exists on the Lease, that the lessee has complied with all applicable laws and Lease provisions and has paid all rentals (no royalty is due as the leased lands were not developed).


