Sovereign lands in Corte Madera Creek, city of Larkspur, Marin County.

AUTHORIZED USE:

Continued use and maintenance of an existing ramp and floating boat dock.

- 2. On December 21, 1994, the Commission authorized a Recreational Pier Lease with Christopher B. McCluney, Trustee. That lease expired on November 30, 2004. Christopher B. McCluney, Trustee of the Christopher B. McCluney Trust 1991, u/t/a dated October 17, 1991, is now applying for a new Recreational Pier Lease. Applicant qualifies for a Recreational Pier Lease because he is a natural person who has improved the littoral land with, and uses the upland for, a single-family dwelling.




