#### **CONTINUATION OF RENT**

#### LESSEES:

Wesley McClure and Larry M. McClure

#### AREA, LAND TYPE, AND LOCATION:

0.05 acres, more or less, of tide and submerged lands in Old River, at Eucalyptus Island, near the city of Stockton, Contra Costa County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing 125 foot long submerged electric power cable, 225 linear feet of protective structure (piling breakwater), and a 17 foot by 28 foot L-shaped fishing platform.

#### LEASE TERM:

Ten years, beginning February 1, 2000.

#### **CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$242 per year, effective February 1, 2005.

#### OTHER PERTINENT INFORMATION:

On December 17, 1981, the Commission issued a ten-year General Lease — Right of Way, to Leonard J. and Betty M. Low for an electrical power cable, protective structure and recreational use. On August 30, 1989, the Commission reissued a ten-year General Lease — Right of Way to East Bay Excavation Co., Inc. and Wesley and Fontella L. McClure for the same purpose. On December 3, 1999, the Commission issued a ten-year General Lease — Right of Way Use to Wesley and Larry M. McClure for the existing submerged electrical power cable, protective structure, and an L-shaped fishing platform. The electrical power cable is an armored cable from a PG&E power pole on Bras Island, crosses the Old River Island to Eucalyptus Island, and serves the lessee's


