CONTINUATION OF RENT

LESSEE:

Delta Yacht Club

AREA, LAND TYPE, AND LOCATION:

0.770 acres, more or less, of tide and submerged lands in the San Joaquin River, near Stockton, San Joaquin County.

AUTHORIZED USE:

The continued use and maintenance of an existing 30 foot by 600 foot floating boat dock, walkway, and approximately 600 feet of bank protection.

LEASE TERM:

20 years, beginning September 16, 2000.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$4,193 per year, effective September 16, 2005.

OTHER PERTINENT INFORMATION:

On April 25, 1968, the Commission issued its original lease to the Delta Yacht Club. The lease was subsequently reissued in 1980 for a 20-year period expiring on September 15, 2000. On April 24, 2001, the Commission issued a new General Lease – Recreational and Protective Structure Use for a period of 20 years beginning September 16, 2000.

The Delta Yacht Club was founded in 1941, is a non-profit corporation, and is located on a 36-acre site on Tule Island. The lessee has the right to use the uplands adjoining the lease premises. The facilities of the Delta Yacht Club are used by members of the Club members on a first-come, first-served basis.


