LESSEE:

Golden Gate Water Ski Club P. O. Box 23 San Lorenzo, CA 94580-0023

AREA, LAND TYPE, AND LOCATION:

Approximately .86 acres, more or less, of tide and submerged lands in Old River, at Golden Isle, Contra Costa County.

AUTHORIZED USE:

Continued use and maintenance of an existing facility consisting of 22 boat docks, walkways, and bank protection.

LEASE TERM:

20 years, beginning September 26, 1999.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$697 per year to \$802 per year, effective September 26, 2005.

OTHER PERTINENT INFORMATION:

On September 26, 1979, the Commission approved a General Permit – Recreational Use to the Golden Gate Water Ski Club. That lease expired on September 25, 1999. On February 8, 2000, the Commission approved a new General Lease – Recreational and Protective Structure Use to the Golden Gate Water Ski Club beginning September 26, 1999, for the continued use and maintenance of 22 boat docks, walkways and bank protection.


