## CONSIDER ACCEPTANCE OF A QUITCLAIM DEED FOR 22 ACRES OF LAND AND AUTHORIZE THE ADMENDMENT OF LEASE PRC 8041.9

#### APPLICANT:

Ronald S. Wong and Letha B. Wong Donna Maria Montosa Joseph R. Martin and Charlene J. Martin

#### LOCATION:

Approximately 22 acres of land including the bed of Lost Slough, within the Cosumnes River Preserve, Sacramento County.

#### **BACKGROUND:**

The owners of the subject property, along with the Federal Bureau of Land Management (BLM) (Manager of the Cosumnes River Preserve), have requested that the California State Lands Commission (CSLC), accept a quitclaim deed to approximately 22 acres of land including the bed of Lost Slough, that will then be leased to the BLM for inclusion into the Cosumnes River Preserve.

This portion of Lost Slough is crucial to the Cosumnes River Preserve's management plan that involves an adjacent 146-acre parcel known as the "Wong Property". The Preserve's goal is to convert the Wong parcel from a dry fallow field into a wetland habitat for waterfowl such as the Northern Pintail Duck and Canada Geese. In order for this to occur it is essential that the Preserve first, obtain access to a water source, and secondly, a means of transporting the water to the Wong parcel. The Lost Slough parcel is capable of satisfying both of these needs in that the Slough itself would provide the necessary water supply while an existing pump station (that will be retrofitted) on the property would transport the water from the Slough to the newly established wetland habitat.

At it's June 19, 1998, meeting, the Commission authorized the purchase of a 263-acre parcel of land adjacent to the Cosumnes River Preserve in Sacramento County. The subject parcel has been leased to the BLM for inclusion in to the Preserve. The CSLC is a partner in the Preserve along with the BLM, California

Department of Water Resources, California Wildlife Conservation Board, Sacramento County, The Nature Conservancy, American Farmland Trust and Sacramento Valley Open Space Conservancy; Supporting agencies include: Environmental Protection Agency, Bureau of Reclamation, U. S. Fish and Wildlife Service, and National Fish and Wildlife Foundation.

The goals of the Cosumnes River Preserve are farmland preservation, habitat protection, and floodplain management. Working cooperatively with private landowners and purchasing land or easements from willing sellers, the partners in the Preserve have protected over 13,000 acres in Sacramento County since its initiation in 1984. The cumulative investment in the preserve so far has been over \$35 million; much of this raised by the Nature Conservancy, corporations, foundations, and private individuals.

These natural habitats are particularly important because they span the zone between the Sacramento-San Joaquin Delta and the low foothills within the corridor of the last remaining undammed river flowing westward out of the Sierra Nevada, providing an important continuous corridor for mammal and bird migration.

Because the Cosumnes River Preserve supports a mosaic of habitats, it is an ideal wintering ground for hundreds of thousands of migratory birds, including the Tundra Swan and the Greater Sandhill Crane, listed as threatened species by the State of California. The Cosumnes River Preserve hosts the largest known population of Giant Garter Snakes, and contains critical habitat for the Swainson's Hawk, both of which are endangered species.

Staff has concluded that the subject property is useful for the public trust purposes of open space and wildlife habitat. The subject property will be leased to the BLM for inclusion in the Cosumnes River Preserve.

#### OTHER PERTINENT INFORMATION:

1. Acceptance of Quitclaim: Pursuant to the Commission's delegation of authority and the State CEQA Guidelines [Title 14, California Code of Regulations, section 15060(c)(3)], the staff has determined that this activity is not subject to the provisions of the CEQA because it is not a "project" as defined by the CEQA and the State CEQA Guidelines.




