#### AREA, LAND TYPE, AND LOCATION:

0.030 acres, more or less, of sovereign lands in the Petaluma River, city of Petaluma, Sonoma County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing pier, ramp, and a floating boat dock.

#### **LEASE TERM:**

Ten years, beginning April 27, 2000.

#### CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that rent be continued at \$123 per year, effective April 27, 2005.

#### OTHER PERTINENT INFORMATION:

1. On April 24, 2001, the Commission authorized a General Lease — Recreational Use to Financial Portfolios, Ltd. for the continued use and maintenance of a pier, a ramp, and a floating boat dock. The Lessee owns the uplands adjoining the lease premises, located in the Petaluma River, in Sonoma County. Lessee does not qualify for a rent-free Recreational Pier Lease because it is not a natural person, and the upland has not been improved with a single-family dwelling.
