**RECREATIONAL PIER LEASE**

**APPLICANTS:**

Jay E. Price and Paula E. Stahl

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in Donner Lake, near the town of Truckee, Nevada County.

**AUTHORIZED USE:**

Removal of an existing recreational pier, not previously authorized by the Commission, and the construction, use and maintenance of a new recreational pier as shown on the attached Exhibit A.

**LEASE TERM:**

Ten years, beginning December 8, 2005.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance in the amount of no less than \$300,000.

**OTHER PERTINENT INFORMATION:**

1. Applicants own the upland property adjoining the lease premises.
2. The existing recreational pier was constructed in 1975 by the previous upland owners and was never authorized by the Commission. Applicants are now proposing to remove the existing pier and construct a new recreational pier. Applicants qualify for a Recreational Pier Lease because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. Applicants are now applying for a new Recreational Pier Lease.

CALENDAR ITEM NO. C19 (CONT'D)

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905 (c)(1).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

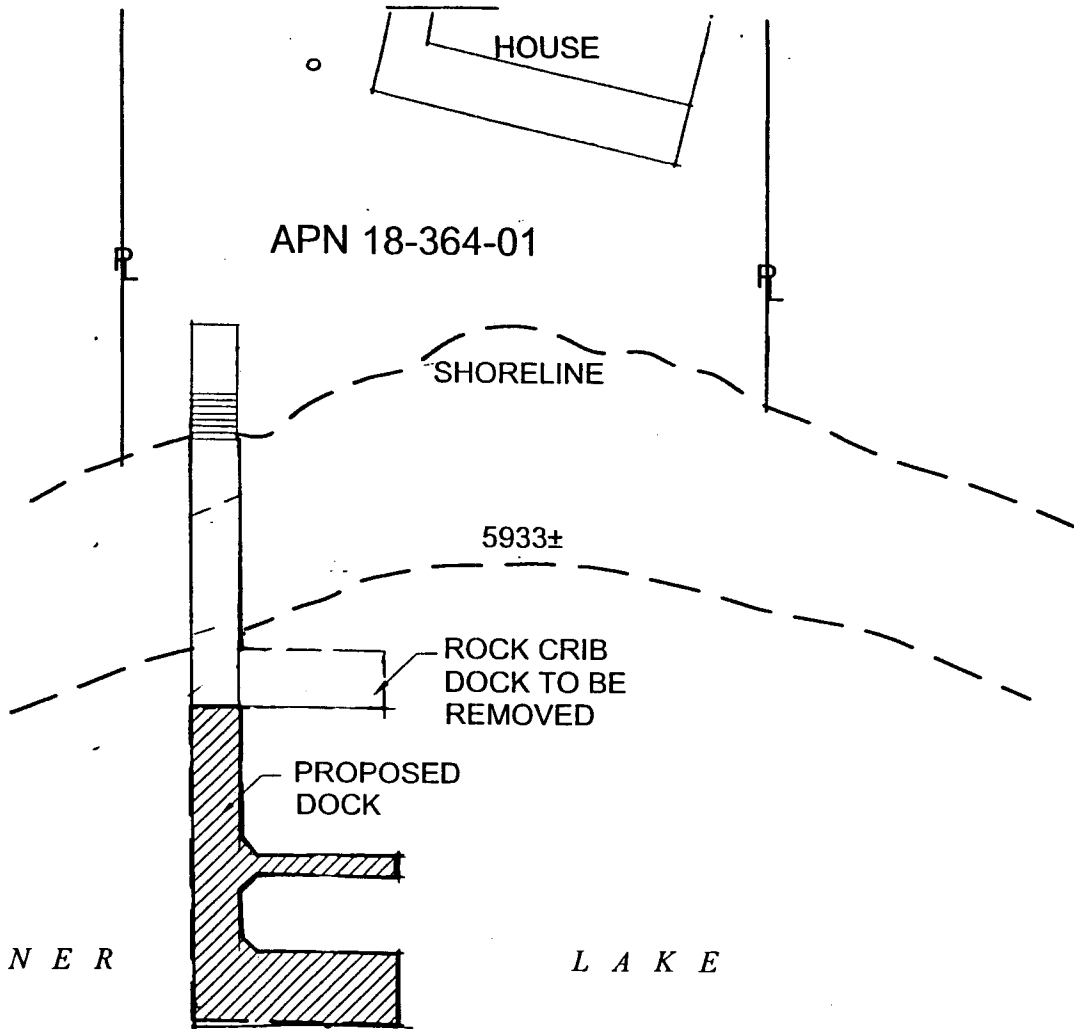

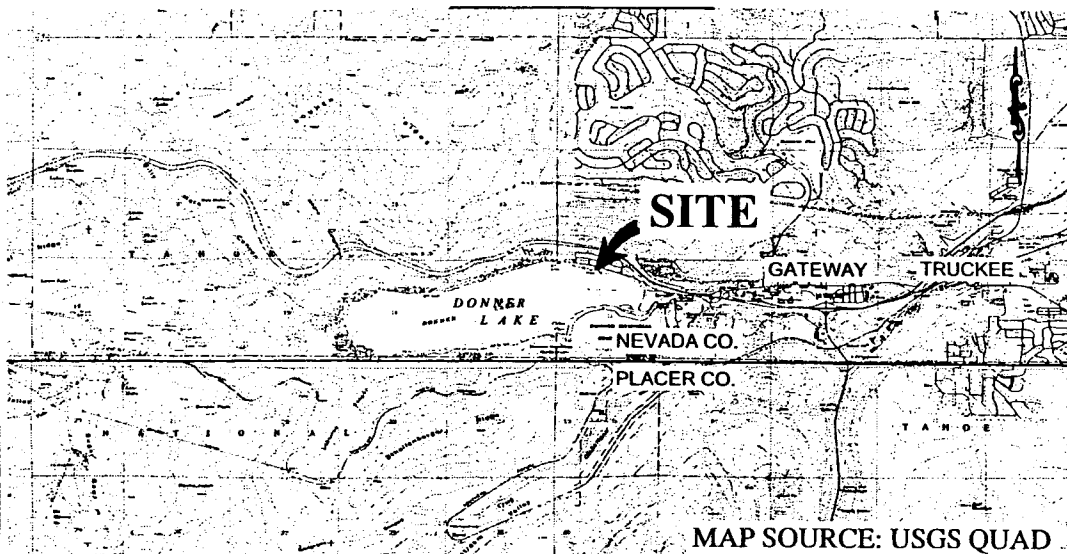
